



## LAKE COUNTY 6TH IN AUTO LICENSES

Fees Paid in 1930 Place It in That Rank in State; List of Others

The county attained sixth place in . the volume of automobile license fees paid to the state during the year of 1930 according to a report issued by William J. Stratton, secretary of state during the year of 1930 according to a report issued by William J. Stratton, secretary of state. St. Clair county led all of the downstate counties for payments during the year being second to Cook county.

St. Clair county replaces Kane county at the end of 1929 with a total of \$379,444 and retained its lead at the end of 1930 with a total of \$405,536. Peoria county finished second among the downstate counties with \$400,446; Winnebago fourth with \$383,525; Madison fifth with \$378,051; Lake sixth with \$370,505; Rock Island seventh with \$314,441; Sangamon eighth with \$310,764, and LaSalle ninth with \$301,438.

Cook County Total

Cook county's total for 1930 was \$7,721,814, an increase of \$747,836 over 1929.

The statistics, showing the annual automobile license fee expenditures of the respective counties, will be turned over by Secretary of State Stratton to the finance department of the state government where they will be used as the basis for allocating each county's share of the three cent gas tax.
