LEGION COUNCIL HAS ITS MONTHLY SESSION

Meets in North Chicago Friday Evening of Last Week; Proceedings Detailed

(by Dan Hunt) "A new plan has been put into effect at North Chicago hospital No. 105," said Dr. Henry St. Antoine to the Lake county Legion meeting at North Chicago Friday, Feb. 20 "Such a radical departure from customary activities in a hospital of this sort, the plan was inaugurated only after most careful investigation.

"We have taken the best patients in the hospital and placed them in a ward by themselves. There are no guards, no nurses or orderlies on duty in this ward. From among the men themselves, by popular ballot, were chosen a commanding officer, officers of the day, orderlies, and various committees deemed necessary for a selfgoverning organization.

"Since the new regime has taken charge we are proud to say that the men have taken a real interest in their own activities. The officer of the day checks up on all men on leave at bedtime and reports to his commanding officer, and he in turn to the hospital authorities. This new ward is always spotless and orderly for the men are far stricter with themselves than the hospitals dare to be. Many other fine improvements have developed in this ward. In fact we are so pleased with its success that we plan to increase its membership rapidly as behavior warrants. This new thought has wrought wonders in the men and I believe that men from this ward, on leaving the hospital as 'cured' will stay cured and will not be compelled to return after a probationary period as in the past.

Many Groups Aid

"Many organizations have aided the hospital authorities in bringing new pleasures and helps for the men. One furnished a piano, another magazines and newspapers, pictures, chairs and other furnishings have been forthcoming to make the room have a 'homey' atmosphere. And to top it off the Sparton Radio Corporation donated a fine new radio.

"I could tell of many other fine things that patriotic organizations are doing for the boys but the best way for the public to know about them is to call in person. To that end I have asked and received the Eighth District American Legion and auxiliary promises to sponsor Hospital day on May 12. On this day we will be prepared to show the new wards now under construction comprising some 971 new beds. I wish I could personally reach each and every citizen in Lake county and ask them to come and see what a government hospital is doing for the ex-service men."
