Field Museum Sends Archeologists to Search for Sites of Lost Race

The present expedition has a wider scope of operations than those which preceded it.

After landing at Belize, the expedition will proceed by boat up the coast to the mouth of the New river, and thence inland on the river to the head of navigation. Thence by mule pack train and on foot for many miles the journey will continue to the ancient city of Kax Nnuic (Maya name meaning "Man of the Woods") which is situated on the frontier between British Honduras and Guatemala. There, with a party of Maya diggers recruited from among the native inhabitants, certain ruins will be excavated which promise to yield a rich collection of Maya antiquites for the museum, probably dating back to a time approximately coincident with the beginning of the Christian era or earlier.

When this work has been completed, the expedition will transfer its activities to the southeast Peten district of Guatemala, where reconnaissance work will be carried on through an extremely dense tropical forest region, uninhabited for many years, in search of the sites of ancient Maya cities known to exist but hitherto nesday, Feb. 18. never definitely located. Work here will be entirely on foot, as the trails are too poor to take mules.

CREATING AND DEFINING ELEC-TION PRECINCTS IN THE HIGH-LAND PARK EAST PARK DISTRICT BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE HIGHLAND PARK EAST PARK DISTRICT, COUNTY OF LAKE AND STATE OF ILLINOIS: SECTION 1. At North Chicago and Highland Park the amount needed is fixed at \$150,000.

Libertyville is listed for an \$80,000 appropriation which Postmaster E. E. Ellsworth says is insufficient for the purchase of property and construction of a new building.

Zion is to get a \$75,000 appropriation which will probably be sufficient to purchase property and at least start a new building.

Barrington, with the smallest appropriation, being listed for \$70,000. is also speculating about the amount as that would not build a post office of sufficient size in Barrington.

An appropriation of \$160,000 to purchase a site and start preliminary work on a federal building for Lake Forest was included in the second deficiency bill which has passed the house and senate during the present session of congress.
