

Acquit Dzan of Bank Robbery Charge Last Week in Circuit Court

Frank Dzan, former convict, last week was acquitted after two hours of deliberation by a circuit court jury on a charge of robbing the Mundelein State bank December 6 in which \$3,600 was taken.

Dzan, through Attorney Frank McDonnell, presented an alibi showing he was in Chicago at the time of the robbery. Dr. J. I. Hustin of Chicago declared that Dzan came to him as the robbery was being staged, and Frank Chesno, a druggist, declared that Dzan appeared before him after visiting the doctor to have a prescription filled.

Leo Dorfler and S. E. Worthem, bank tellers, identified the defendant and Chicago police testified to the criminal record of the man as a part of the prosecution's case.

Dr. Hustin, on cross examination, admitted that he did not know exactly the time of Dzan's call for medical assistance.
