

JUNIOR WORKSHOP PLAY IS SUCCESS

Presented Saturday Night in
Ravinia Village House;
Good Work

The Ravinia Junior Drama Workshop performance of "The Dover Road," on Saturday night at the Ravinia Village House, must be rated as a distinct success, even though the house was not packed.

As the name implies, the group is composed entirely of young people, most of whom have had considerable experience in high school and college dramatics. Early in the season they put on walking rehearsals of two original one-act plays; after which they became ambitious to produce a full length play.

In this, their first finished performance, they have shown good taste and discrimination in the selection of their play. It represents Milne at his best, whimsical and subtle humor, a nicely balanced mixture of sophistication and moral preachment and just enough satire to give the whole a tang. They also had the very good fortune to attract the interest of a very able young director, Mr. Geoffrey Baker of Chicago. The smoothness and finish of the performance by the well chosen cast attested Mr. Baker's ability.

Good Work

Royal Gunnison did very outstanding work as the eccentric Mr. Latimer. This elusive and almost mystical part for one so young as Mr. Gunnison and yet, at all times, he was most effective and convincing. Gertrude Williams gave just the right nuances of refinement and sophistication to her interpretation of Anne, a level headed young modern. Betty Jacobus was delightful as the exasperatingly devoted Eustasia. H. Allen Porter gave an excellent portrayal of the very disgruntled Leonard. Donald Vaughan played the vacillating Nicholas with the bouyant spon-

Lantz Is Sentenced To State Prison on Charge of Forgery

Oscar Lantz, 27, formerly of Highland Park, charged with having victimized more than a dozen Waukegan merchants with bad checks was sentenced by Circuit Judge Ralph J. Dady last week to serve from one to twenty years in Joliet state prison.

Lantz was convicted on the charge of forgery in circuit court earlier in the week, three women on the jury voting on the verdict of guilty.

The defendant police charged, had been circulating forged checks in the North Shore cities for nearly five years. Prior to his conviction in circuit court he always managed to escape prosecution by making the checks good after charges had been filed in police court, according to Waukegan newspaper reports.

Following the passing of a series of checks in Waukegan Lantz fled to California. He was traced there by Assistant Chief of Police Edward Ahlstrom and arrested by California authorities at the request of the local police official. Lantz waived extradition.
