County Has Deficit of \$157,300, Mostly Due to Poor Relief

Lake county is at present \$157,300 in the red, according to Supervisor Arthur W. Vercoe, chairman of the finance committee of the board of supervisors.

In addition to that overdraft the county still has \$200,000 anticipation warrants that have not been taken up.

These financial conditions of the county were revealed at last week's meeting of the board when a resolution was passed to seek the co-operation of the H. C. Spears Company of Chicago in making a bond issue for \$200,000 to meet the "outstanding obligations on pauper aid."

The greater portion of the overdraft has been due to the increased demands of residents in the county for poor relief. Efforts have been made by the special poor relief committee appointed by former Chairman C. H. Stratton and composed of Supervisors William J. Obee, Ira W. Holdridge and James O'Connor to have the state legislatures pass an act to permit the county to make a bond issue without a referendum.

Under the present plans, if the state legislature permits the county board to make the bond issue which will carry 5 per cent interest to be matured in ten years, the Spears company will aid in the printing and selling of the issue for one half of the premium. On the approval of the legislature the issue may be released about July.
