

#### More Than Half Taxes In County Are Unpaid May 1 Official States

More than half of the taxes in Lake county were still unpaid when the May 1 deadline for payment without penalty was reached.

It was estimated by County Treasurer Jay Morse that more than \$3,-700,000 out of a total of \$6,087,000 was still unpaid. This is only about 40 per cent of the total.

County officials regard this as a serious situation and are urging those who can possibly do so to speed up payments.

At this time last year over \$4,000,-000 had been turned into the county treasurer, it is said. Delinquent taxpayers are required to pay only 1 per cent penalty during the next month.

Among the delinquents are many owners of lots in the subdivisions throughout Lake county, it is said. It is anticipated that considerable property will have to be sold for taxes this year, according to those familiar with the situation.

AN ORDINANCE FIXING THE SALARY OF THE MAYOR AND COMMISSIONERS OF THE CITY OF HIGHLAND PARK, ILLINOIS.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF HIGHLAND PARK: SECTION 1-That the salary of the Mayor and Commissioners (Four) for the fiscal year beginning May 1st, 1931, and ending April 30th, 1932, be fixed at such sum as is proas required under the laws of the State of Illinois, and the ordinances of the City of Highland Park, during the term of his office, and that such officer shall receive no further compensation from the City of Highland Park for the duties of such office during the term

That the salary of the Mayor be and the same is hereby fixed at the sum of One Thousand Two Hundred Dollars (\$1,200.00) per annum.

That the salary of each of the Commissioners be and it is hereby fixed at the sum of Nine Hundred Dollars (\$900.00) per annum. SECTION 2-That the salaries provided for in Section One of this ordinance shall be due and payable in semi-monthly installments on the First and Fifteenth day of each month for the preceding half month of their services during the term of their office.

SECTION 3-That the salary of the Mayor and Commissioners shall be paid from the salary of Officers Fund provided for in the Department of Public Affairs. SECTION 4-That all ordinances or parts

of ordinances in conflict with this ordinance are hereby repealed. SECTION 5-This ordinance shall be in force and effect from and after its passage, approval and publication. BENJAMIN F. LEWIS,
