Reports Burglary of Cuba Township Home

Furniture and guns, valued at several hundred dollars, have been stolen from the home of E. L. Huntington, Cuba township, during the last few weeks, he informed the sheriff, Lester Tiffany, last week. The burglary was not discovered until yesterday.

Another burglary occurred in the county last week, the Jensen filling station, twenty second street and route 42, being visited by robbers some time between 2 and 6 o'clock in the morning, and 52 cents stolen from the cash register, and about \$10 from a cigarette dispensing machine.

Huntington told Sheriff Tiffany that the burglary at his home was the third in recent months. He believes that some one in the neighborhood is responsible, timing their nocturnal forays on nights when they know he would not be at home.

The latest robbery resulted in the loss of several guns, including a 22-calibre rifle, a double-barrel muzzle-loader, and a single-barrel breech loader.

County to Take Court Action to Recover on Bank Bond, Report

Lake county will go into court on October 17, or shortly thereafter, to recover on the \$200,000 bond of New York Indemnity company for losses suffered by the county in the failure of Waukegan State bank, it was reported last week, at the office of State's Attorney A. V. Smith.

The county can not take action before that time because of a provision in the bond contract by which a period of 90 days must elapse between the time call to assume the loss was made to the bonding company and the time suit is filed. George McGaughey, assistant state's attorney, said.

It is probable, it is believed, that the bonding company will fight the case in court. There has been no intimation, it is said, that a settlement out of court will be proposed.
