

#### STATE AUDITOR IN NEW COURT MOVE

cial Grand Jury Had No Power to Indict

State Auditor Oscar Nelson, who is to go on trial with Norman O. Geyer, president of the defunct Waukegan State bank, and George Woodruff, Chicago banker, on Jan. 18 at Woodstock on a charge of conspiracy growing out of the closing of the bank, is reported to contend that the special grand jury has no power to indict him on a charge of malfeasance.

Nelson's counsel, it was said at Woodstock, are seeking to have the indictments against Nelson quashed. The attorneys contend that the grand jury has not the jurisdition to indict an official for malfeasance. Only the legislature can impeach him for such alleged conduct.

"The statute is quite broad," "State's Attorney A. V. Smith stated today, "to permit a grand jury to indict a county or state official on charges growing out of an investigation such as we had here."

The conspiracy indictments against Nelson, Geyer and Woodruff were upheld by Judge Ralph J. Dady. On a change of venue, the trial of the three on this charge was transferred to McHenry county, where Judge Edward D. Shurtleff will hear the
