Dismiss Suit Against Casper Santi; Is to Be Settled, Report States

Casper Santi, Highwood private banker and former city collector, was on Tuesday freed on a charge of embezzlement by Judge Ralph J. Dady in circuit court when Assistant State's Attorney Wilfred E. Hall nolle prossed the indictment charging Santi with misappropriating \$8,300 of the city's funds.

The Highwood city council Monday night decided to accept the offer of Santi's relatives to drop the prosecution on arrangements of settling with the city for the funds alleged to have been taken by Santi.

Santi was called to trial Monday afternoon and a jury had been selected by Assistant State's Attorney Hall and Attorney J. A. Miller, counsel for Santi.

Santi still faces a charge of operating a banking institution without a state license in county court. According to his counsel, Santi is making efforts to raise funds to repay all persons who had invested with him.
