

COUNTY ROAD WORK **NEXT YEAR PLANNED**

Lobdell Reports Prospects; Figures on Highway Jobs **Done in 1931**

Work on the construction of Dugdale and Bulkley roads near Waukegan will start this spring or summer if the county road and bridge committee obtains the rights of way releases for these highways, according to a statement issued last week by County Superintendent R. M. Lobdell.

These two important road projects are in the extensive plans for Lake county construction this year. Other road building planned for this year include the paving of the Druce Lake, Slocum Lake and Wadsworth extension roads.

During 1931 the county added approximately 20 miles of concrete highway to the county system, at a cost of \$500,000. The funds for this work were obtained from the \$1,250,000 bond issue, which is being retired by the gas tax refund to the county.
