**Old Vernon Hotel
at Half Day Burns**

The old Vernon hotel in Half Day, was completely demolished when fire swept through the two-story frame structure last week. The building, valued at about \$5,000, lay in ruins today although the Wheeling and Long Grove fire departments were able to check the spread of flames to neighboring structures.

The Vernon hotel, owned by Mrs. Mary Kelley of Chicago, was not occupied during the past three

years. Prior to that time, however, it housed a number of different enterprises during the fifty-year period.

Many years ago, it was known as the most familiar stopping place for tourists and people of Chicago bound for towns of Wisconsin.

Although the structure proper was erected about fifty years ago, a new front for the building was erected about twelve years ago.

Fire officials estimated that the total damage amounted to at least \$5,000.

voted his entire time to legislative work and to the needs and interests of his constituents in their relations with the Federal Government. Even during the present campaign he has been compelled to remain in Washington to attend to most important business, involving the economic and industrial life of the nation.

His policy in legislation has always been to promote the greatest good for the largest number and for the country as a whole. He has opposed unnecessary expenditures and special favors even to large and powerful groups. He will continue to oppose needless expenditures and support all possible economy and retrenchment.

The 18th Amendment became a part of the Constitution before he became a member of Congress. He has supported laws for its enforcement because it is the clear duty of Congress to provide such enforcement. His first opportunity for action on the amendment itself occurred on March 14 last when he supported by an actual vote in Congress the movement to repeal the 18th Amendment and to return the control of intoxicating beverages to the States. On March 25, 1932, he cast his vote in the House of Representatives for the legalization of 2.75 per cent beer in the States which do not themselves prohibit its use. In these positions he was sustained by the clearly expressed sentiment of the voters not only in the 10th District, but by the entire State, and he states further that he will follow the same course on these questions in the future.

**Chicago Woman Victim
of Auto Accident Last
Week at Deerfield, Ill.**

Mrs. Elizabeth McGarrahan, 60, of Chicago was fatally injured and three persons were seriously hurt, one having a possible skull fracture, when a car driven by Kenneth McGarrahan, 30, of Zion, crashed into the rear of a two-ton truck parked on Waukegan road just north of the Deerfield limits at 10 o'clock Thursday night of last week.

The driver sustained a fractured hip, lacerations about the face and hands and a possible skull fracture. His wife, Beatrice, had lacerations about the right hand and a broken right wrist, while a four-year-old daughter, Kathleen, sustained a fractured right leg. An infant son, John, 8 months old, escaped without injuries.

All injured were rushed immediately following the crash to the Highland Park hospital, where Mrs. McGarrahan died. Although still suffering from shock in the accident, all the others were reported as considerably improved on Friday. An inquest over the death of Mrs. McGarrahan was held at the Kelley funeral home Friday.
