**SUPERVISORS RESIGN,
REAPPOINT SEVERAL**

Action Taken To Bring Number on Board Down to New Law Requirements

Thirteen assistant supervisors, two in Deerfield, two in Shields, and nine in Waukegan, on Tuesday resigned from the county board to bring the membership within the required number under an amended act of the legislature.

In Waukegan the following resigned: Walter H. Diesner, Percy Gustafson, Charles Selenak, Charles O. Jones, Emmett McShane, Einar Mohberg, Thomas M. Baron, and Albert Ratajczak and August Cepon of North Chicago. Jack Hoban and R. H. Brenton resigned several months ago when they went on the county payroll.

Appoint One in Shields

Edward M. Mawman of Lake Bluff and Charles Fitzgerald of Lake Forest resigned in Shields and the town board is to meet within the week to appoint either of the men back as a member.

Two in Deerfield

In Deerfield Sam Santi of Highland Park resigned. The resignations of William E. Bletsch and Charles Harbaugh, both of Highland Park, were tendered and accepted and these two men appointed to fill the vacancies created by the wholesale resignations.

Waukegan will have four assistants restored to board membership. They probably, according to opinions of town board members, draw lots to determine the four of the nine former members to be restored.

The amended act of the general assembly was designed to cut down the membership on county boards. Waukegan, under the old law, was entitled to one supervisor and 15 assistants. Now it can have one supervisor and eight assistants.

Holdovers

As Assistant Supervisors Ira Holdridge, Frank Burke, A. J. Sutkus, and Walter Piquette were holdovers they will continue to serve until next spring when they are subject to re-election.

In Shields township the holdovers were Thomas V. Murphy of North Chicago and James Kelly of Lake Forest. The holdover in Deerfield was Arthur Vercoe of Highland Park.

Shields can have under the new law a supervisor and three assistants instead of four assistants as was the case until last night.

Deerfield is entitled to a supervisor and three assistants, rather than six assistants as was the case. The resignation of Paul L. Udell, of Highland Park, at the time Benton and Hoban left the board, placed that township in a position last night to drop two men instead of three as would have been the case had Udell still been an assistant.

Slashed in Half

The new law provides for one assistant for every 5,000 residents, instead of 2500 residents, which was the old law before the amendment.

The board under the old law could have 45 members, and under the new it is entitled to 34, a reduction of 11 assistants.

Action Of Review Board Expected To Result In Lowering Local Taxes

Members of the taxpayers associations throughout the county are gratified at the action of the board of review in declaring a 15 per cent reduction in assessments for next year and point out that even if taxing bodies in some instances are obliged to increase the rates to obtain sufficient funds, this will not be the case generally, so that even if some of them do raise the tax rates, there still will be a reduction in the total of taxes.

This is expected to be the case in this township, as some taxing bodies already have their rate up to the maximum under the law, and any increase in rates by the others will not result in a tax boost generally. It is expected that in this township the net result of the reduction will result in at least a 10 per cent reduction in taxes next year, as far as local prospects are concerned. Of course there is some indication that the state may have to radically increase its rate to cover relief funds expended, and if no bond issue is approved for the purpose, the state rate may be boosted as much as 30 cents on the dollar, it is predicted in the Chicago papers.

Route 42 Through This City Is Renamed Marine Highway for Fair

Selection of State Highway No. 42, U. S. 41, which passes through Highland Park as one of fourteen World's Fair highways leading to A Century of Progress—Chicago's 1933 International Exposition—was announced today by Major E. S. J. Irvine, chief of the Exposition's transportation division.

The road will be named the Marine route, after one of the most interesting features of the Exposition.

Marine route will be marked with 18-inch metal enamel signs, bearing an emblem of an anchor, and fastened to metal standards. These will be located at average intervals of one-tenth of a mile.

As the motorist enters Chicago's suburbs, he will find gaily painted information booths, with attendants ready to give out information concerning routes, tourist camps, hotel accommodations, the various attractions, and so forth. Arrangements are being made to have banners hung across the road.

Although no estimates have been made of the attendance expected at A Century of Progress, the transportation division is making preparations to handle a total of 50,000,000 paid admissions during the five months of the Exposition, June 1 to Nov. 1.

Hundreds of thousands of these pleasure seekers will pass through Highland Park, both going to and coming from the Fair, and many will undoubtedly stop long enough to buy gasoline, oil, other supplies and services for their cars; food, refreshments, tourist supplies and clothing.

Four of Bandits Who Held Up N. Chicago Bank Are Captured

Four of the five bandits who held up the Lake County State bank in North Chicago Sept. 5, were captured in Chicago Tuesday and reports from Chicago police were that all four united in a confession, naming the fifth member of the gang. The four captured are listed as Ernest Rupperecht, ex-convict; Clifford Heaney, who, it is stated, confessed shooting Mrs. Monetta Steffen, bookkeeper, who is in a very critical condition in a Waukegan hospital; Joseph Beck and Frank Wagner, all of Chicago. Their ages range from 19 to 24. The fifth man named is Charles Pisewick, also of Chicago. His arrest is expected shortly.
