Cottage Owners Plan Appeal from Order of Court in Damage Suit

Lake Zurich cottage owners plan to appeal from an order entered by Circuit Judge Edward Shurtleff in Woodstock demanding them to pay \$7,250 damages to August Froelich and Margaret Pearce for damages resulting from a temporary injunc-

Of this amount \$5,000 is to go to the defense attorneys, Runyard & Behanna, and Werner Schroeder. The court refused to allow expenses for witnesses.

Attorneys Sylvester Taylor and 0. W. Nelson, who represented the cottage owners, were given 60 days to prepare their appeal.

The cottage owners petitioned an injunction two years ago to restrain Froelich and Mrs. Pearce from preventing boating, fishing and bathing in the lake on the presumption, that it was a navigable body of water and therefore government and not private property.

The supreme court held the lake to be the private property of the two, and gave them full jurisdiction over it.

Froelich and Mrs. Pearce sued for attorney's fees and for damages caused by the injunction that precluded them from getting revenue rom the lake for a summer.

Runyard and Schroeder are preparing to sue the state for damages for an injunction sought when the state's attorney intervened. Testimony will be identical to that offered against the cottage owners, who claimed they had riparian rights when they sought the injunc-



Boecek has a cival suit against Kro for \$200 besides the criminal warrant charging larceny. The hives were built specially and the bees were from very good families and a little more valuable than the ordinary run of insects.
