November 29, "Unemployment Insurance."



## BELIEVES REMAPPING OBSTACLES REMOVED

### Rep. Lyons Sees in Action of Supreme Court Chance of Redistricting

The only legal obstacle to the redistricting of Illinois, as attempted by the last legislature, was removed in the decision rendered Tuesday by the United States Supreme court, and Lake county may yet be in a district with only the north tier of townships in Cook county, instead of a great portion of Cook county, Rep. Richard J. Lyons stated last Thursday.

Rep. Lyons was chairman of the reapportionment committee of the legislature and was greatly disappointed when his committee's plan met defeat and kept Lake county from dominating a new congressional district, instead of leaving it in the minority district in which it is new a part.

### Increases Downstate Dstrict

Under the Illinois reapportionment act the two congressmen-at-large for the state were eliminated, and the representation of the Chicago area, comprising Cook, Lake, Du-Page and Will counties, was increased from ten to fourteen districts. Downstate retains its thirteen representatives but increases the number

"If the matter is now left up to the state legislature, I will introduce the necessary bills to make it constitutional, unless the Illinois supreme court reverses its original opinion and allows the act to become a law, Rep. Lyons said today.

Lyons May Be Candidate Providing the reapportionment is carried out, Rep. Lyons may become a candidate for congress, in the opinion of his friends, although he would not verify this in his conversation with the News-Sun.

The new apportionment would give Lake county a dominating position for vote-getting and would practically assure Lake county's candidate a victory, providing he were alone in the field against whoever the Cook county end of the district put into the running.
