**Democrats Call Link
Qualified for Coroner**

A. J. Link is well qualified by profession and general experience to fill the office of coroner of Lake county, according to Lake county Democrats.

**Howell Is Held to
Grand Jury in County**

Louis Howell, commissioner of the Sauganash Park district in Chicago, last week waived preliminary examination before Judge Harold Tallett of North Chicago, and was held to the grand jury on a charge of murdering Carl H. Reese, Chicago race track gambler, in Lake county on Oct. 12.

Howell was released on a bond of \$20,000 provided by George and Ethel Koester, of Chicago.

**Gives Opinion Upon
Care of Paupers by
Townships Under Law**

Mandamus action or prosecution for malfeasance in office may be taken to force the township supervisor to care for the poor in his township, Attorney General Oscar Carlstrom has advised State's Attorney Louis F. Reinhold, Stephenson county.

Reinhold requested information as to whether a grocer might furnish groceries for a poor family and recover from the township, or whether a private citizen or the Freeport Community Service Bureau might supply necessities and recover from the township.

"A grocer," Carlstrom held, "may furnish groceries to a poor family and recover from the township only in case of emergency. The grocer may not on his own motion, without consulting the supervisor or overseer of the poor, if possible, render aid and bind the township therefor unless an emergency exists."

"And the emergency must, in my opinion, be such that immediate aid is necessary, such as milk for a starving child. The emergency must in its nature be acute, for example, the immediate need of a physician or surgeon.

"I regret that I know of no plan other than to use the legal remedies against the supervisor for his failure to do his duty, and at the same time for the cities of the township to give emergency relief when emergencies actually exist."

**Carleton Vail Will
Filed in Court; Lists
Estate of \$100,000**

The petition to probate the will of the late Carleton M. Vail, of Highland Park, last week was filed and set for hearing before Judge Theodore Forby in probate court. It disposes of an estate of \$100,000 in personal property. The hearing was set for Nov. 14.

Five persons, a daughter, Edith, a son, Carleton Jr., two brothers, Roger and Malcolm, and his mother, Mrs. Jennie Vail, were bequeathed \$2,500 each.

Two employes of H. S. Vail & Co. and two servants in the home were allowed \$500 each.

The residue of the estate was left to the widow, Mrs. Winifred C. Vail.

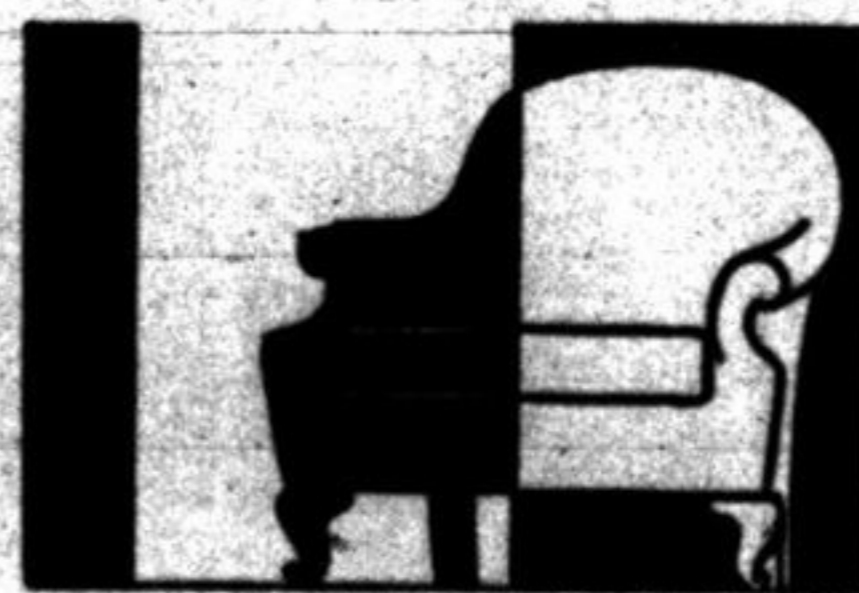

STRAY FACTS

The first road east and west through Highland Park was the Deerfield road, which was begun in 1854 or 1855 and finished two years later. It was not graded. Central avenue, in Highland Park, was the first graded road, and Port Clinton road, the forerunner of Sheridan road, the next. After that, the graded streets were all on the west side of the railroad for years.

Lake county was given \$32,793.50 for county highway construction, during the last half of October, by the State Department of Public Works and Buildings. This money comes from the county gas-tax allotments and state-aid road fund.
