The election of the most important tax saving officer in Lake County confronts us. That officer is County Auditor.

The law provides when a county reaches a certain population the office of County Auditor automatically becomes necessary. Lake County, by the 1930 census, passed the population requirements. Now we must have a man big enough for the big job.
