Strangely enough, this play, with the smallest audience of all the Players' full length plays, was probably the best. Although the direction showed through in spots and an occasional prompt was noticed, those who stayed away are told they missed a play of near-professional calibre, and the audience, small as it was, demanded five curtain calls.

Del Davis, Bob Arnold and Laura Browning scored decided hits with their performances. The Highland Parkers, usually reluctant to acclaim individual acting, gave applause to these three readily and eagerly.

Lou Hickman as Olivia was excellent. It is another part that will go down as one of the best bits of

acting in the Players' chronicle. Ross Hickman did not rise to his heights as in "Children of the Moon," but was thorough and convincing. Brian, played by Fenton Hopkins, swung into the mood of the play quickly after getting over the stiffness of a "first appearance." A splendid job. Melanie Thurman turned in a creditable performance as the maid, a small bit, but acted with intelligence.

All in all, the play was pleasing to the audience, and in spite of the box office can be put down as one of the triumphs and not one of the failures.—Contributed.
