Trustee M. A. Pottenger reported that the septic tank at the west ditch had been repaired, two manholes and two inlets had been replaced there for observation purposes. In the extensive repairs made two large timbers were found in the tile which, had never been removed.

Complaints were heard by various property owners concerning sewers, objectionable trash burning, etc.

The North Shore Gas Co. refused a petition for gas, containing over twenty signatures, in a northwest subdivision, stating that there were not sufficient users of gas to give the subdivison gas service.

The village relief projects have been turned down by the state, but the board will make another plea for help.

The state motor fuel tax allotment for Deerfield in June was \$314.40 for the upkeep of Deerfield's arterial highways.

A request was made for street lights on County Line and Wilmot Roads, as per ordinance which calls for one light for every 400 feet. Lack of money prevents the village from acting.
