Consumer's Corner

When you go to buy a Thanksgiving turkey, find out whether it is "young" or "old." That makes a difference in the cooking.

A "young" turkey is usually less than 1 year old. At that age it should have soft meat and a flexible breast bone. Young tom turkeys weigh 9 to 18 pounds. Old toms weigh 16 to 30 pounds. Young hens weigh 9 to 12 pounds as a rule. Old hens weigh 10 to 15 pounds.

Look for a bird with plump, broad breast; with thighs, back, and all bones covered with a thick layer of flesh; preferably with streaks of fat down the back, over the hips and along the sides of the breast.

Look for a bird that has been well-dressed. The whole body clean, feet and all. No food in the crop, practically no pin feathers showing on breast or back or any part. No bruises, no broken skin, no discolorations from poor bleeding, such as shown on wings and tail and wherever large feathers grow.

A fifteen-pound turkey will make about 20 generous home servings. That is, allow for each person half to three quarters of a pound, market weight, picked but not drawn.

The Lake County Consumers' Council, recently formed in the interests of everyone who spends money, has acquired an office in the same building as the Highland Park Social Service, 549 Central Avenue.

A series of short articles is planned for this column on what could be done and has been done in the matter of quality grading in the field of consumers' goods.

There is no doubt that all of us want to spend our money in the most intelligent way possible, but that isn't so easy in this day of thousands and thousands of brands of food, clothing, textiles, and household equipment, to mention a few of the things we use every day. The very richness of the machine age and its multiplicity of goods put us consumers at a great disadvantage.

It is all right for a horse-trader to gloss over a horse's age when the horse stands there for any buyer to inspect his teeth. But we consumers can't look at the teeth of a package of breakfast food, a bottle of mouthwash, a can of peas, or the multitude of synthetic materials that masquerade under synthetic names. In our grandfathers' day, to discover he had been cheated was a very rare event for any normally shrewd person. Nowadays, not only do we expect less wear from our purchases, but we've become accustomed to paying for the best, only to find we've been fooled time and time again.

There are, or could be, government grades for practically everything we buy in our retail stores. All that needs to be done is to persuade manufacturers that it would be good business to put these government grades on their labels.

In Canada, for instance, quality grading for the canning industry is obligatory, and Mr. C. S. McGillivray, chief canning inspector, says, "The increase in sales of fancy qual-

ity and choice quality goods from year to year is an excellent evidence that the people are paying attention to the better grades."

Which shows, we believe, that the Canadian regulations have worked against quality chiselers and have rewarded the packers of high grade products.

In many industries here, with the added impetus given to the problem by the Consumers' Advisory Board under the NRA, the best element among the producers is determined to have quality labeling adopted as a means of doing away with cut-throat competition of misleading quality, and of gaining the co-operation of the consumer. If these producers could know that they had us consumers really backing them up and determined to have this information, we'd be getting this provision into the various codes in double-quick time.

Certain pamphlets are being issued by the Consumers Advisory Board, and the Consumers Council of the AAA, Washington, D. C., which anyone may have for the asking. Foremost among these is the Consumers' Guide, a bi-weekly bulletin to aid consumers in understanding changes in prices and costs of food and farm commodities and in making wise, economical purchases. This is issued by the Consumers' Council.

Others are "Standards and the Consumer," a statement made at the Code Authority Conference, March 7, 1934, by Dr. Robert A. Brady, special adviser on standards for the Consumers Advisory Board; and "Quality Standards for Specific Industries," which includes silk goods, hosiery, fresh and canned fish, dry cleaning, and household ice refrigerators. These are put out by the Consumers' Advisory Board. Write for them today.
