

Consumer's Corner

A new fruit, arriving on the market in quantities, at a price we can all afford, in the time of greatest need of such an addition to vary the monotony of the winter diet, is indeed news. The fruit is the attractive calavo you have been seeing for sale locally and the reason, a crop of calavos such as California has never before produced.

Since the calavo has never before been available in such quantities, we know you will be interested in some suggestions as to how to serve them.

But first to prepare them. Nothing was ever simpler. Do not remove the skin until you have halved the fruit lengthwise and removed the seed. Then peel it if it is to be used in slices or rings or cut in dice. The skin of the softened fruit will separate easily from the green flesh beneath. If it is to be served instead in strictly California style, on the half shell, your work of preparation is over. Serve on a bed of salad greens with lemon juice and salt or a sharp French dressing.

If quantities must go further, combine the fruit in slices, cubes, balls, or wedges with any vegetable such as beets, carrots, tomatoes, onions, asparagus, and celery.

There is no limit to the fruits that will lend their combined flavors to a successful salad. Or serve sliced calavo on beds of lettuce or any available salad green. Sea foods and calavos combine in salads as if intended for that very purpose. A simple tart dressing is usually preferred.

Serve a calavo and chicken entree on your next luncheon menu. Calavos belong to the list of fruits which are not improved by cooking, so the diced calavo is added to the creamed chicken just before serving. Add pimientos in strips for contrast of color, if desired. Whether you go to the effort of making pattie shells or crostades or use the simpler base of triangles of toast, your guests will applaud the result for its distinctively different note and its additional flavor. Substitute mushrooms, sea food, sweetbreads, lamb, or veal for the chicken and note the way the calavo extends the more expensive ingredients of this universal favorite.

A cocktail of sea food and calavos diced or cut into French balls insures the success of any dinner menu. Serve with the usual cocktail sauce. The sea food used may be simply canned red salmon in flakes with celery added for chewiness. Oysters, crabmeat, tuna, lobster, or shrimp, fresh or canned, will blend equally well with the adaptable calavo. The cocktail should be served chilled as usual, in cocktail glass or the half of a calavo may be used as a container. In this case the sea food and celery are placed in the seed cavity and flooded with cocktail sauce.

Announce Examination For Position of Fort Sheridan Postmaster

At the request of the Postmaster General, the United States Civil Service Commission announces an open competitive examination to fill the position of postmaster at Fort Sheridan. It is expected that appointments will be made as a result of this examination unless it is found in the interest of the service to fill the vacancy by transfer or promotion. This is not an examination under the Civil Service Act and rules, but is held under an Executive order of July 12, 1933 providing for such procedure. The position carries a salary of \$2,300 per year.

The Post Office Department will not appoint to the position of Postmaster any of the following; the husband or wife of a rural carrier; a person concerned in a contract for carrying the mails, either as contractor, sub-contractor, or surety; nor any member of his immediate family.

Applicants must submit to the examiner on the day of the examination their photographs taken within two years, securely pasted in the space provided on the admission cards sent them after their applications are filed. Tintypes or proofs will not be accepted.

Applicants for this examination must have reached their twenty-first birthday and must not have passed their sixty-sixth birthday on the date of close of receipt of applications. These age limits are waived in the case of veterans of the World War, the Spanish-American War, and the Philippine Insurrection; provided that to get the benefit of such waiver, documentary proof of such service must be submitted with the application.

Applicants for this examination must have actually resided within the delivery of the vacancy office for one year immediately preceding the closing date for receipt of applications.
