Nelson, County Treasurer and ex-officio County Collector of Lake County, Illinois, will on September 30th, A.D. 1935, before the County Court of Lake County, Illinois, in the Court Room in the County Court House in the City of Waukegan, Lake County, Illinois, make application for judgment against the said lands, town lots and real property hereinafter described for the amount of said special assessments, matured installments thereof, interest and costs due thereon and for an order to sell said lands, town lots and real property for the satisfaction thereof. Take notice further that the said Allen J. Nelson, County Treasurer and ex-officio County Collector for the County of Lake and State of Illinois, will on the second Monday succeeding the date on which judgment shall be taken, to-wit: the 14th day of October, A.D. 1935, offer and expose to public sale at the County Court House in the City of Waukegan, Lake County, Illinois, all or such portion or portions of the property hereinbefore described for the amount of special assessments and matured installments of special assessments, interest and costs thereon; for which judgment shall have been taken, and shall then remain unsatisfied. Said sale will commence at the hour of nine o'clock A.M., Central Standard Time, on the 14th day of October and will continue from day to day until the same shall be completed. If for any cause such sale shall not be rendered on said 30th day of September, then such sale shall commence on the 2nd Monday after such judgment shall be rendered. A list of all such delinquent lands, town lots and real property upon which the special assessments or installments thereof remain unpaid with the names of the owners, if known, the total amount due thereon, and the year for which the same are due is as follows: Payment of delinquent special assessments may be made to the City Collector any time prior to date for tax sale.
