AN ORDINANCE REGULATING TRAFFIC AND VEHICLES AND FIXING THE AMOUNT OF LICENSE FEES FOR VEHICLES IN THE VILLAGE OF DEERFIELD. BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF DEERFIELD, LAKE COUNTY, ILLINOIS, THAT: ARTICLE I. DEFINITIONS - GENERAL PROVISIONS. SECTION 1. Definitions. Whenever in this ordinance the following terms are used, they shall have the meaning respectively ascribed to them in this section.

SECTION 2. Classification of vehicles. For the purposes of this ordinance, motor vehicles shall be divided into two divisions: First, vehicles which are required for the carrying of not more than seven persons; second, vehicles which are designed for pulling or carrying freight and also vehicles designed and used for carrying more than seven persons. SECTION 3. Obeyance to police. Members of the police department are hereby authorized to direct traffic in accordance with the provisions of this ordinance, or in emergencies as public safety or convenience may require, and they shall be lawful for any person to fail or refuse to comply with any lawful order, signal or direction of a police officer.

SECTION 14. Unattended vehicles. No vehicle shall be left unattended while the motor of such vehicle is running; and no motor vehicle shall be left unattended on any highway or public place of the village, unless it is equipped with a muffler or "cut-out" in good working order. SECTION 15. Unnecessary noise. It shall be unlawful for any person to operate a motor vehicle in a manner which produces unnecessary noise, or to use any horn, bell, or other signaling device in a manner which produces unnecessary noise.

SECTION 16. License fees. The license fee for any motor vehicle shall be as follows: Motorcycles - \$2.00; Motor vehicles of 35 H.P. or less - \$4.00; Motor vehicles of more than 35 H.P., except motor trucks, motor coaches, motor buses and motor vehicles used for commercial purposes or for hire - \$6.00; Motor trucks, motor coaches, motor buses and motor vehicles used for commercial purposes or for hire - \$10.00; One ton capacity and not over two ton capacity - \$10.00; Over two ton capacity - \$15.00.
