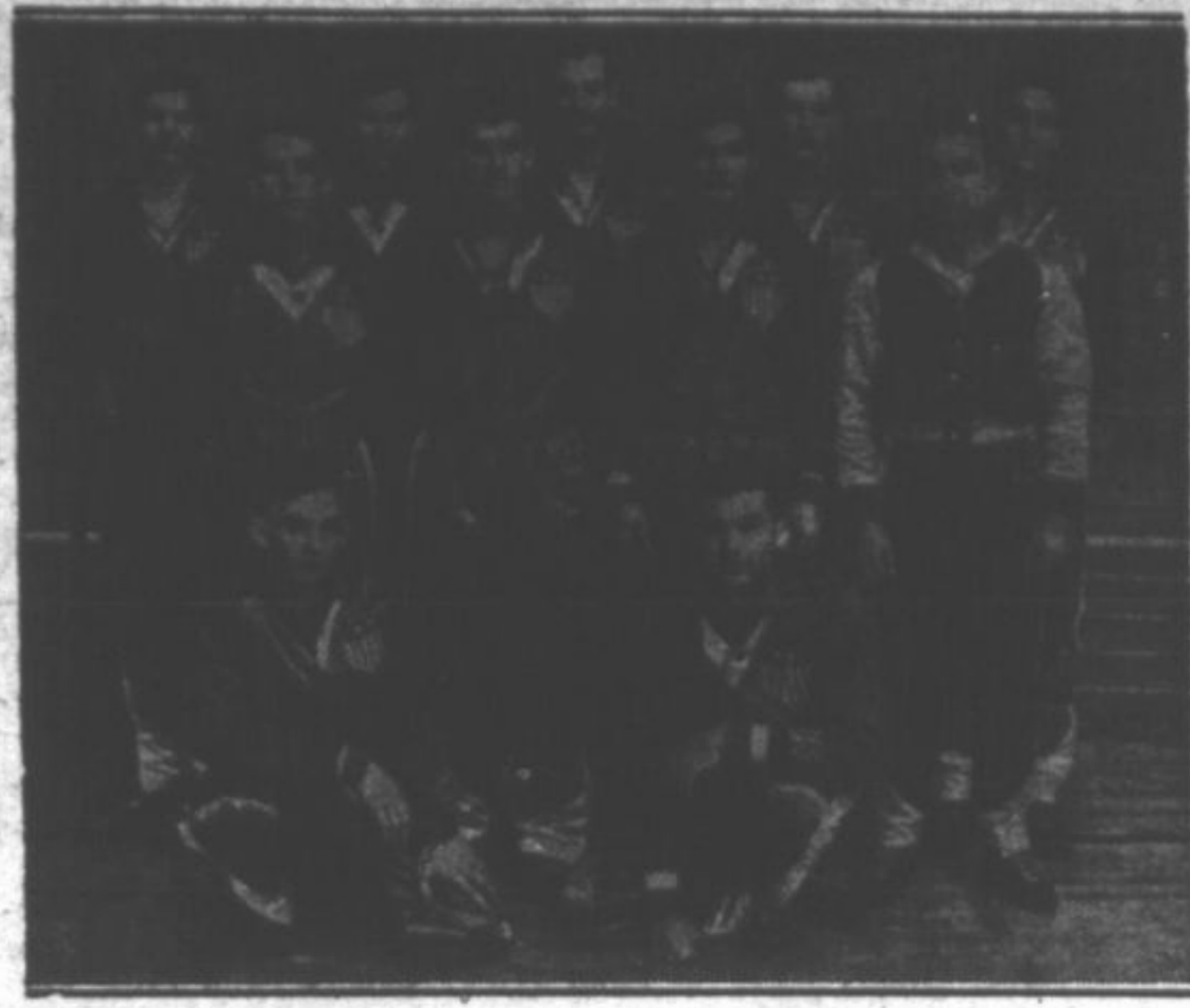


### National A. A. U. Cage Champs To Invade Chicago



### DENVER SAFEWAYS PLAY COLLEGIANS

Chicago, Ill., Jan. 10, 1933.

Boasting the same All-American lineup that triumphed over the best in the west in the final Rocky Mountain A. A. U. playoffs, and then went on to capture the U. S. title in the National A. A. U. games over 54 college and state champs at Denver last year, the famous Denver Safeways will make their only Midwest appearance on Friday night, January 21, 1933, against the crack Chicago Collegians, Negro quintet, at the 132nd Regiment Armory, at Madison and Rockwell Sts.

Here is basketball at its best—dazzling, sensational and thrilling—with two teams in a class by themselves in magical passing and showmanship. The Safeways have proven themselves the ultra of the cage sport, but many Chicagoans will back the nifty Collegians, rated National Amateur Champions and claimants of World's Amateur cage title, to upset America's standard-bearers.

**Greater Than Ever**  
The A. A. U. champions are greater than ever. Their lineup of All-American stars includes the best in the game—Chicago's own Bob Gruentig, 6 ft. 9 in. center, and Werner Frank, Jack McCracken, "Tex" Colvin, Ralph Bishop, Bauer, Wells and Lucy.

This group plans to keep playing together until they have won the 1940 Olympic title for the United States, a goal, incidentally, also being aimed at by the Collegians.

ians, the "Wizards of the Court," as they have so aptly been named by a Chicago sports writer.

Never in Chicago's sports history have been presented. Colorful ceremonies, martial music and unique introductions of the teams will lend magnetic appeal. Chicago is wildly excited about the contest and a packed house is certain to watch the great A. A. U. champions defend their prestige against probably their most dangerous rivals.

**Movie Stars On Hand**  
The Denver Safeways will be paraded on not only by their imposing A. A. U. trophy that will be on display, but also by the presence of movie stars who have promised to be present and will be introduced to the crowd.

On Monday evening, January 22, the highly syndicated Phillips "66" squad featuring five All-Americans including the famous Chuck Hyatt of Pittsburgh, Joe Fortenberry, Jay Wallenstrom, Ray Ebling, Jim Babcock and many others, will make their appearance at the same Armory court to face Frankie Harmon's Chicago Demons, nationally famous De Paul University quintet, including Ed Campion, Willie Phillips, Nick Yost, Ray Adams, Fred Knes and Bill Wendt.

In order to accommodate out of town fans who might desire to see the big attractions, a large block of tickets has been set aside and mail orders, accompanied by money order or American Express checks and sent to Harry Hannin, Room 403, 17 N. Wabash Ave., Chicago, Ill., will be promptly filled. It is expected that Chicago fans will completely buy out their allotment of tickets before the night of each big game, which, incidentally, will be supported by two other outstanding cage clashes.

The supporting card will get under way promptly at 7:15 p. m.

### Board Approves Purchase Of Site For Sanitarium

With the purchase of a site for the Lake county tuberculosis sanitarium approved by the board of supervisors, architects were assigned Monday to start the preparation of plans for the construction of a 92-bed hospital building.

A contract for the purchase of approximately 22 acres bordering Belvidere street near the west Waukegan city limits was approved by the board of supervisors.

Proposals that the tuberculosis sanitarium board obtain some of the county poor farm property at Libertyville, or the vacant land adjoining the county hospital in Waukegan had to be set aside because the law, under which the voters approved the tuberculosis tax levy, prohibits the use or purchase of county-owned property.

Dr. Charles K. Petter, newly appointed director and superintendent of the sanitarium, stated before

the supervisors that there were 500 active tuberculosis cases in the county at the present time.

He said that a hospital building of the size proposed by the tuberculosis board of directors should be sufficient to hospitalize those who need the 24-hour a day rest cure. Other patients will be cared for at their homes.

The board of directors, Dr. Theodore S. Proxmire of Lake Forest, Victor Woertz of Waukegan, and James F. Stiles, Jr., of Lake Bluff, and Dr. Petter are now assigned the duty of handling the tuberculosis situation in the entire county.

While construction plans are underway, Dr. Petter will conduct weekly clinics at St. Therese hospital. These clinics will be held each Wednesday starting at 9 a. m., replacing the monthly and bi-monthly clinics formerly conducted by the Lake County Tuberculosis association.

The fight against tuberculosis in Lake county was voted by the people at the November 1936 election when a maximum 15-cent tax per \$100 property valuation was voted for a period of 10 years.

Property valuations for 1937 will be the first to be assessed for the tuberculosis fight. With the val-

uation of the county property at slightly over \$84,000,000, the tax, payable this coming spring and summer, will total \$126,000.

The tuberculosis board in preparing its budget for the current year has asked the board of supervisors for an appropriation of \$129,000.

Of the appropriation, \$50,000 was for building purposes; \$46,000 for care and hospitalization of patients; \$15,000 for the purchase of a sanitarium site; \$10,000 for the care of patients in homes and the remainder for the salary of the superintendent and for maintenance.

With tax payments averaging 80 per cent of the extensions, the \$15,000 appropriation for a building site will dwindle to approximately \$12,000 in actual income.

To expedite the working conditions of the tuberculosis board, the supervisors yesterday approved the plan of issuing \$30,000 in tax anticipation warrants. Only a part of these anticipation warrants are to be used for the purchase of the land.

At the next meeting of the board of supervisors on Feb. 8, the tuberculosis board may seek a ballot for an enabling bond election.

The voters of the county will be asked to approve the issue of \$400-

000 in bonds to meet the construction costs of buildings for the sanitarium. A bond issue, it was said, would not result in any further cost to the property owners, but would enable the tuberculosis board to go ahead in the campaign to eliminate the dread disease at once instead of waiting until the final tax levy in 1947.

Interest and the retirement of such a bond issue would be paid from the annual 15-cent tax levy over the 10-year period.

### 37 More Students Than Last Year In Graduating Class
