CONSTITUTIONAL AMENDMENT

EXPLANATION OF PROPOSED AMENDMENT

- 1. Proposed section 5, like present section 5, provides that the State shall not be interested
- in any bank. 2. The amendment omits the provision from present section 5 requiring submission to the voters of acts of the General Assembly relating to banking. It provides in proposed section 6 that acts of the General Assembly relative to banking shall not go into effect unless such acts receive the affirmative votes of not less than two-thirds of the elected members
- 3. Proposed section 8 repeals the provision of present section 6 making stockholders of a State bank liable to the creditors of the bank over the amount of stock held by such stockholders for liabilities of the bank.


