## The Highland Park Press Offers \$1,500 In Cash Prizes

### School Districts To Elect Board Members April 8th

The election of members of the Board of Education in Districts 106, 107 and 108 will be held Saturday afternoon, April 15, between 2 and 4 o'clock.

In District 105 (High school) the terms of two members of the board expire.

Frank W. Read of Lake Forest, who has served as president of the Board, and Mrs. Laura D. Smith of Highland Park are the retiring members. Both are running to succeed themselves. No other petitions have been filed.

For many years it has been the policy of the Board to have two members from Lake Forest, two from Highland Park and one from the western section of the district as a fair representation, and it is hoped that this same policy will be maintained this year.

The polling places will be: The auditorium foyer at Highland Park High School; in Deerfield at the Town Hall, and in Highwood at the Oak Terrace school.

Three candidates have filed petitions for election to the Board of Education, School District 107, Highland Park. These are Mr. Francis M. Knight, 411 Lake avenue, for President of the Board; Mr. Thomas H. Compere, 163 Clifton avenue, and Mrs. Edna O. Laegler, 620 Skokie avenue, for members of the Board.

Mr. Knight, a graduate of Yale university, a one-time teacher in the Hotchkiss School for Boys in Connecticut, is Vice-President of the Continental Illinois National Bank and Trust Company of Chicago. He has been an active, civic-minded resident of Highland Park for many years, being particularly interested in the Ravinia Summer Music concerts. Two of his children have graduated from the Elm Place school and two others are still in school there. Mr. Knight has been a member of the Board of Education for three years and is therefore well acquainted with its problems.

Mr. Howell W. Murray, who has so faithfully and efficiently served as President of the Board of Education of this district for the past ten years, is retiring from the Board. Mr. Murray's work in keeping the schools solvent, in carrying on through the depression years, in helping to secure constructive school legislation, has been outstanding. His sincere interest in the schools and his untiring efforts in their behalf will be greatly missed.

### Candidates Listed In Highwood Election

One alderman will be elected in each of Highwood's four wards, with the exception of the newly created third ward, where two will be chosen, when the city election is held Tuesday April 18th. The only organized slate in the field is the Citizens ticket headed by John Simpson, former city treasurer and clerk.

The Citizens ticket is composed of: First ward, Simpson; Second ward, Albert Bjork; Third ward, Paul Paglia and Joseph Calkins; Fourth ward, Arthur Kehrwald. Albert Axt, a former city clerk is opposing Simpson in the first ward, Williams in the second ward, who has three times defeated Bjork for the post will attempt to extend his record to four victories. Third ward opposition to the Citizens ticket is provided by Richard Shannon, former Highwood fire chief and Variato Campagni, a construction foreman. Edwin Cowgill, who has served eight terms as an alderman, will oppose Kehrwald in the fourth ward.

### 3 Day Dental Health Program Planned in School District 108

A dental health program covering three days March 29, 30 and 31, is being planned for all of the four schools in District 108. Mrs. Valta McGrath, the school nurse, has secured the cooperation of the Division of Dental Health Education of the Illinois State Department of Public Health and the Highland Park Dental Association.

Dr. M. Emmerson, from the Dental Division of the State Public Health Department, assisted by Miss Hanlin, State Dental Hygienist, will give educational talks on teeth and their care, to the various rooms and classes in the Lincoln Avenue, Ravinia, Braeside, and Ridge schools. Literature, especially prepared for the different age levels, will be given to the children and teachers, telling about the structure of teeth, the influence of diet on the teeth, mouth hygiene and related matters.

The members of the Highland Park Dental Association are contributing their services to examine the teeth of all the children in the schools. A chart will be made of each child, showing the state of health of the mouth and teeth and noting any abnormal conditions. Parents will be notified if any attention by the family dentist is advisable.

This program is in harmony with the National Health Program to improve health, happiness and comfort of the citizens. It will locate any diseased conditions in their incipency and may save a child a night of tooth ache and the possible loss of valuable teeth.

### Young Woman Dies In Auto Crash; Companion Injured

Sally Timonen, 26, of 1110 S. Green Bay road, was instantly killed and her companion, Eugene D. Harper, 24, of Wilmette, was seriously injured early Saturday morning, when their car crashed into a public service pole at the intersection of Oakwood and Deerfield avenues.

The young woman, who was employed as a domestic at the above address, was the former wife of Don Bartoli of Highwood. Harper is an employee of the Hughes Oil company.

The accident was discovered by employees of Santi Bros, dairy who arrived at work about 4:45 a.m. Police believed that the accident occurred about 15 minutes previously. The couple were found in their wrecked car, the doors of which had to be opened with crowbars.

Apparently Harper lost control of his car while traveling east at high speed and crashed head-on into the electric pole. The splintered pole toppled on a brick building wrecking a corner of the structure.

It is believed that Harper had intended to turn south on Green Bay road, became confused and continued east on Deerfield avenue, which is a dead end street running into Oakwood avenue. It was at this intersection that the accident occurred.

The condition of Harper, who was seriously injured and taken to the Highland Park hospital, is reported as somewhat improved. Harper resides at 616 Gregory avenue, Wilmette, and is the son of an Armour Institute of Technology professor.

Coroner John L. Taylor has ordered the inquest continued pending Harper's recovery.

It was rumored that Miss Timonen and Harper had eloped to Indiana several weeks ago and were married, but according to Highland Park police, no records have been found to verify the marriage.

Funeral services for Miss Timonen were held yesterday morning at 10 o'clock from Kelly's chapel on Sheridan road.

The deceased is survived by one child, a daughter.

### Fire Department Kept Busy Sunday with 17 Fire Runs

Another sign of spring is the increased activity of the local fire department. On Sunday last, in the space of four hours, the engines were called out on seventeen runs. At one time during the day there was no equipment left in the station, as the fire apparatus was spread over the four corners of the town.

Fire Chief Hoskins reported that all but two of these fires were due to shrubbery and burning leaves. In the Krenn and Dato subdivision on the northern boundary of town, one square mile of shrubbery was burned. This was the largest fire reported. Another call was the result of a blaze in the attic of 871 Ridgewood drive where papers had been set on fire by a child playing with matches. The loss, however, did not exceed \$25. A scorched playhouse on South Sheridan road resulted in damage amounting to about \$20.

As is usual, the first spring Sundays bring industrious home lovers forth to put lawns in shape and remove all leaves from budding gardens. It is also usual that as autumn leaves are burned, the brush fires are started. Thus, the forty m.p.h. gale that blew out of the southeast on Sunday not only brought balmy weather but also caused the spread of these grass fires. This is a particularly appropriate time to want to clean up the lawns, but the season is in the same way, particularly susceptible to high winds which do not seem to have any regard for the boundary line of lots and yards. Fires started in one place may very likely ensue in another, so it is only considerate that these ambitious spring gardeners mind their dress closely and not tempt the strong wind with a few forgotten embers.

### Review Mayoralty Candidates For Coming Election

A brief review of candidates who are seeking office in the coming City election, Tuesday, April 18th, will be presented weekly preceding

reviews will present an impartial outline of the background of the men who are running for office.

Mayor William Dooley, who is seeking reelection, and his opponent Major Frank J. Ronan are being reviewed this week.

Mayor William M. Dooley was born in 1862 just seventy-six years ago in Chicago. He was the sixth son of Mr. and Mrs. William Dooley who had migrated from Ireland in the early part of the century. In 1866, when he was four years old, his family of five brothers and one sister moved to Highland Park where Mayor Dooley has lived for the past seventy-two years.

He received all of his education at the local schools in district 107, and a few years after his formal education, he became associated for eight years with W. F. McLaughlin and Co., as a salesman. For the following twenty-two years he followed the banking profession. During the World War he contributed his time and efforts to the cause of Liberty Loans, and after that period he became connected with the Allen Finger Printing Co. Recently he has been active in the work of the Federal Housing Administration.

In regard to his public service, Mayor Dooley served as Postmaster of this city for thirteen years; as Alderman for four years, as City Treasurer for four years, and as School Treasurer for twenty-six of government he held the office of Mayor from 1909 to 1911; and under the commission form of government from 1935 to the present. Aside from these municipal offices he is also the local representative of the American Red Cross.

Mayor Dooley feels that his experience in public office, his long and close association with the city of Highland Park, both socially and politically, and his working knowledge of this municipality's governmental problems, properly and adequately qualify him for re-election to the office of mayor.

Major Frank J. Ronan was born in Albany, New York just sixty-nine years ago, and when still a baby, he and his family moved west to Chicago; it was there that he received his grammar school education. Shortly after that he went to Oakland, California and attended high school. At the age of fifteen he went to sea as a cabin boy on a coastwise steamer running a course between Seattle and San Francisco at the time of the Chinese exclusion riots. In 1889 he became a boomman in the development of the Pacific coast region and pioneered through the great plains area between the Mississippi River and the Rocky Mountains. During much of this period he was in business on the westward moving American frontier. After several years of participation in the early commercial activities of the plains, Major Ronan travelled to the Northern regions of Wisconsin, Michigan, and

### Baby Fatally Burned In Bedroom Blaze

Harold Glandt Jr., nine-month-old son of Mr. and Mrs. Harold Glandt, 647 Grand View avenue, was fatally burned yesterday afternoon when fire, apparently started by crossed wires under an overstuffed chair next to the child's crib set the crib ablaze.

The baby's grandmother, Mrs. Albert Glandt, ran upstairs and smothered the child from the blazing crib. It was rushed to the Highland Park hospital, where attendants said that it was severely injured, suffering from first, second and third degree burns. The child passed on at 8 o'clock last night.

Highland Park firemen, called to the scene, extinguished the fire, which had spread to another bed in the room. Damage was confined to the one upstairs bedroom.

The baby's father, Harold Glandt, is employed at the First National bank here.
