**3 Local Men Are Active In Drive For Welfare Camp**

The Highland Parkers are exceedingly active as directors of the Young Men's Jewish council, which this week opened its campaign for \$50,000 for the operation of Camp Wooster at Round Lake, Illinois. The three Highland Park residents are Alfred S. Aischuler Jr., 1302 Judson avenue; Vernon Fox, 740 S. Ridge avenue; and Joseph Mayer, 228 Hazel avenue.

Camp Wooster, which is entering its 27th consecutive season provides 1600 underprivileged boys from the congested areas of Chicago with two weeks of fresh air, fun and good food. Originally founded in 1914 with two tents accommodating 25 boys on rented property, the camp now is completing the last of 30 modern cabins, while its playing fields, beach, competent staff and complete program place it among the leading boys' camps of the nation.

The camp acquired its present site in 1923, since which time it has grown steadily. Every two weeks during the summer months a new group of 320 boys is taken to camp for 14 days of camping fun. Of the total number of 1600 boys, 600 are drawn from the three boys' clubs in various under-privileged areas of the city which are operated by the Young Men's Jewish council. The balance are taken at the suggestion of various clinics, orphan asylums and social service agencies.
