Even after an absence of two weeks the council calendar was hardly what one might term as crowded. Evidently sensing the lull in civic affairs the mayor announced that there would be no meeting until March 10.

The council did, however, touch upon one subject dear to the heart of every local government and that is the question of Home Rule. It appears that there is a bill in the legislative hopper in Springfield that would set up a schedule of minimum wages for certain classes of municipal employees. Such a law would naturally take the power of assigning minimum wages out of the hands of the local government and deposit it with the state. This bill apparently is just one more straw in the drift of the wind toward centralization of power about which everyone is hearing so much about these days. --

To put itself on record as being decidedly against any measure that would take matters of purely local interest out of the jurisdiction of the municipality the council passed a resolution opposing the bill now before the legislature in Springfield.
