Proposed Boat Landing Pier in Lake Michigan at Fort Sheridan, Ill.

When an application is received for a War Department permit to authorize proposed work in or over a navigable water of the United States, Department regulations state that notices regarding the matter shall be sent to all persons deemed likely to be interested, in order that any protests from the standpoint of navigation may be received.

This notice is to inform interested persons that the U. S. Government Military Reservation, Fort Sheridan, Lake County, Illinois, acting through Lt. Col. S. J. Raymond, Quartermaster, has made application for a permit to construct a boat landing pier in Lake Michigan.

The proposed boat landing pier is approximately one-half mile south of the north edge of the U. S. Government Reservation and will extend 150 feet into the lake. It is to be of steel H-beam construction with a timber deck.

The plans may be seen at the office of the undersigned and will be mailed to interested persons upon request.

Any objection to the proposed work from the standpoint of navigation should be mailed to the undersigned within seven days from the date of this notice.
