Sherwin-Anspacher Talk To Women's Club Feb. 19

On February 19, at 12:45 p.m., the fine arts department of the Highland Park Woman's club will present Dr. Louis W. Sherwin, Highland Park Presbyterian (genial and popular pastor of the church, in a review of Louis Adamie's latest book, "A Nation of Nations." Those who heard Dr. Sherwin review "The Apostle" by Sholem Asch, will not want to miss this opportunity to hear him again.

This program is sponsored by the book review committee of the fine arts department, under the leadership of Mrs. Frederick O. Toof.

Dr. Sherwin is a native of Bradock, Pa., and grew up in the Pittsburgh steel area. He is a graduate of Allegheny college, Pa., a Phi Gamma Delta, and the proud possessor of the much coveted Phi Beta Kappa key.

His theological training was received at Boston university school of theology, and the Auburn Theological seminary. Since Dr. Sherwin's graduation, Auburn Theological seminary has become affiliated with Union Theological seminary, so he is now an alumnus of Union.

Mrs. Sherwin, the former Lorena Palm, of Meadville, Pa., and the two Sherwin daughters—Mrs. H. Howard Black of Wappingers Falls, N. Y., and Miss Virginia of Highland Park—are well known to Highland Parkers.

Dr. Sherwin's pastorates took the family first to Indianapolis an dthen to Oil City, Pa., and in 1928 they all sailed for England where Dr. Sherwin did graduate work at Mansfield college, Oxford, finishing at the Divinity school of Yale university at New Haven, Conn.

His pastorate in Highland Park began in 1931, and his keen interest in community activities is too well known to need recounting here. The Highland Park Social service fund drive of the Highland Park Red Cross, board of the Presbyterian home in Evanston and many important affairs of the Chicago Presbytery have felt the

Noted Radio Commentator at Temple Men's Club, Glencoe, February 27

Just returned from England and France, Clifton M. Utley, whose name and voice are known to millions of radio listeners, will address a feature meeting of the Men's club, North Shore Temple Israel, in the temple auditorium, Lincoln and Vernon avenues, Glencoe, at 8 p.m., Wednesday, February 27.

Born in Chicago, graduate of the University of Chicago, a director of the Chicago Council on Foreign Relations, Mr. Utley is regarded as an outstanding authority on topics of both national and international interest.

Presently editor of the Chicago Sun's air edition, Mr. Utley has likewise achieved national recognition for his clean-cut daily radio broadcasts on the air continuously since 1935. During 1941 and 1942 he was a news analyst for Skelly Oil company over the NBC network; he was also heard over WGN with a five times a week program sponsored by the Studebaker corporation.

Mr. Utley began his broadcasting weekly for the Charles A. Stevens and Co. in 1935 and still serves in this capacity. Likewise he is presently reporting the news of the day on two sponsored programs for the Quaker Oats Co. and the American Dairy association.

His subject, "After Victory," should be especially timely and of interest. Due to his many radio commitments, Mr. Utley is now limited in his speaking engagements, although he has addressed as many as 175 conventions, trade associations, service and women's clubs within a single year.

All North Shore residents, men, women and their families, are invited by the Temple Men's club to hear this noteworthy address. Admission to all is free. Refreshments will be served in the temple lounge.

In view of the popularity of the speaker and his outstanding contribution to American journalism as well as to radio, it is expected that the temple auditorium will be filled to capacity to hear Mr. Utley, and to participate in the discussion period following his address.

Veterans Must Protect Right to Vote; Register!

DeWitt J. Manasse, service officer of the Highland Park American Legion, calls to the attention of all former members of the armed forces of the United States that they should not fail to contact the office of County Clerk Jay B. Morse at the county court house in Waukegan, or Edward 394 Central avenue, Highland Park, to check their registration as voters if registered before entering service.

If one is under the age of 21 when entering service, come in and register. Even though you were registered, but have changed your home address at any time, since entry in the service, then send in your new address and the old address from which you last voted over your own signature; and this must be done whether you voted in person or as an absentee voter.

Important to Veterans' Wives: Wives of veterans, who under the constitutional provision, were permitted to vote from residences at which they did not live, must also notify the county clerk of their new address and that of their old one.

Whether or not the former member of the armed forces voted while in the service, he should check his registration at once; to neglect this duty may result in the loss of his right to vote.

Veterans fought for the preservation of this right and they must protect it.

With the complete cooperation of our mayor, J. B. Garnett, the League of Women Voters is inviting all members of the community to a Town Meeting, Wednesday evening, Feb. 20, at 8 o'clock, at the Community Center. The subject for consideration is "Postwar Planning for Highland Park."

Considering our alert citizenship and our capable city officials, the matter of working out a well-planned and thoroughly executed development for Highland Park should not be difficult now that the war is over. Yet the two—citizens and officials—must be brought together to make the plans and to enlist everyone's enthusiastic cooperation in executing them.

With this thought in mind, the board of the League of Women Voters decided to devote its February meeting to the subject of "Postwar Planning," to schedule the meeting for the evening so that the men as well as the women could attend, and to ask the mayor to recommend the speakers.

City-wide interest has developed with an announcement by Harold O. McLain that Congressman Karl E. Mundt, member of the House Foreign Affairs committee, will be the guest speaker at a public meeting, Thursday evening, February 21, at the Lincoln school auditorium.

Congressman Mundt, representing the First South Dakota district, and said to be one of Washington's most colorful personalities, according to information received by Mr. McLain, recently returned to the United States from an extended observation trip to Russia and the Balkans. He was a member of a Congressional group sent by the government to probe into conditions in the area which today is the seat of the world's most portentous political unrest.

The visit to Highland Park by Congressman Mundt is under the sponsorship of the local Men's Republican club and the Deerfield Township Republican Woman's club. It is the third of a series of similar events which have taken place during the winter, designed to develop public interest in and more intimate knowledge of post-war political and economic affairs. Cooperating with the local Republican groups, whose active, paid membership is reported to be approaching the 2,000 mark, is an influential section of the community not avowed members of either party, or the so-called independent leagues.

Mundt a Brilliant Speaker
Cong. Mundt's announced subject is "The Challenge We Face." His reputation as a brilliant speaker, careful observer and constructive thinker, promises an exceptionally profitable evening for his auditors. What the character of his revelations about Russia and the Soviet empire's satellites will be, is a matter of individual speculation, but it is believed he will go as far as diplomacy and good taste will allow.

"Who's Who" publications state that Congressman Mundt has widely diverse interests. After graduating from Columbia university in 1923, he first became a high school teacher and later as chairman of the speech department of Eastern State Normal school. He was vice-president and member of the executive board of the Isaak Walton league from 1937 to 1939. His interest in national political affairs was the outgrowth of academic observation.

Mr. McLain, who is president of the Men's Republican club, extends a cordial invitation to the general public to attend the Feb. 21st meeting. All seats are free.
