PUBLIC NOTICE is hereby given that the general biennial election of the Park District of Highland Park in the County of Lake and State of Illinois will be held in the said Park District of Highland Park on Tuesday, the 1st day of April, 1947, between the hours of six (6) o'clock in the morning and five (5) o'clock in the afternoon of said day, for the following purposes:

1. Electing Commissioners of the said Park District of Highland Park for the following terms:  
Two (2) Commissioners for the full term of six (6) years, and

2. Submitting to the legal voters of said Park District of Highland Park the following question:

Shall the Board of Park Commissioners of the Park District of Highland Park, Lake County, Illinois, be authorized, and empowered to sell at public sale the following described real property:

Commencing at the Northeast corner of the Northeast quarter of the Northwest quarter of Section Twenty-six (26), Township forty-three (43) North, Range twelve (12), East of the Third Principal Meridian, and running thence South on the West line of the said Northeast quarter and on the West line of Hamilton's Second Addition three hundred ninety-seven and three-tenths (397.3) feet; thence East on a line parallel to the North line of said Northeast quarter six hundred twenty and thirty-three hundredths (620.33) feet; thence North on a line parallel to the West line of said Northeast quarter a distance of three hundred ninety-seven and three-tenths (397.3) feet to the North line of said Northeast quarter; thence West on said North line of said Northeast quarter to the place of beginning, containing five and two-thirds (5-2/3) acres, situated in Highland Park, Lake

Second Precinct: All of that portion of the Park District of Highland Park which lies East of the Center line of the East Skokie Drainage Ditch and Southwesterly of a line described as follows: Beginning at the intersection of Beech Street and the shore of Lake Michigan, thence Southwesterly along Beech Street to the intersection of Beech Street and Ridgewood Drive, thence Southwesterly along Ridgewood Drive to the intersection of Ridgewood Drive and South Green Bay Road, thence Southeasterly along South Green Bay Road to the intersection of South Green Bay Road and Edgewood Road, (Edgewood Road being the North line of Section 35, Township 43 North, Range 12 East of the 3rd P.
