Registered Nurses **Needed For Polio Patients**

More registered nurses are needed to serve polio victims in six Chicago area hospitals.

Red Cross announced today that it must recruit graduate nurses for Cook County, Evanston, Contagious Disease, Passavant Memorial, Billings and Michael Reese Hospitals.

"If a registered nurse is permanently employed, we do not wish to take her away from her work," Charles Z. Henkle, chairman of the Chicago Chapter Red Cross, said. "But if she can conscientiously leave or be released for polio duty, she will help to fill an urgent need."

Red Cross recruits nurses for the National Foundation for Infantile Paralysis. The foundation, which pays the salaries of nurses mustered for polio duty, asks those enrolled to serve for at least two months. Only registered nurses can fill polio assignments.

In the last seven months Red Cross chapters throughout the nation have mustered 300 registered nurses for assignment in poliostricken areas. In addition, more than 600 nurses obtained thru Red Cross last year are still on the


