AN ORDINANCE CHANGING THE NAMES AND DESIGNATIONS OF CERTAIN STREETS, AVENUES AND THROUGHFARES IN THE CITY OF HIGHLAND PARK

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGHLAND PARK, LAKE COUNTY, ILLINOIS:

SECTION I. That the name of the street known as Blackhawk Avenue in the City of Highland Park be and the same is hereby changed to that of Blackhawk Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Bronson Avenue in the City of Highland Park be and the same is hereby changed to that of Baldwin Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Center Street in the City of Highland Park be and the same is hereby changed to that of Acme Drive, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Clinton Court in the City of Highland Park be and the same is hereby changed to that of Port Clinton Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Deere Park Drive North in the City of Highland Park be and the same is hereby changed to that of North Deere Park Drive East, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Deere Park Drive N. W. in the City of Highland Park be and the same is hereby changed to that of North Deere Park Drive West, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Deerfield Avenue in the City of Highland Park be and the same is hereby changed to that of Deerfield Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Dell Place in the City of Highland Park be and the same is hereby changed to that of Dell Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as East Parkway in the City of Highland Park be and the same is hereby changed to that of Heron Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as East Street in the City of Highland Park be and the same is hereby changed to that of Shady Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Eastview Road in the City of Highland Park be and the same is hereby changed to that of Barbary Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Ellendale Road in the City of Highland Park be and the same is hereby changed to that of York Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Glenwood Avenue in the City of Highland Park be and the same is hereby changed to that of Sherwood Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Glenwood Court in the City of Highland Park be and the same is hereby changed to that of Buckhorn Court, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Golf View Avenue in the City of Highland Park be and the same is hereby changed to that of Marquette Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Greenwood Avenue in the City of Highland Park be and the same is hereby changed to that of Spruce Avenue, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Midway Avenue in the City of Highland Park be and the same is hereby changed to that of Holly Road, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as North Avenue in the City of Highland Park be and the same is hereby changed to that of Temple Avenue, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as North End Court in the City of Highland Park be and the same is hereby changed to that of Cherry Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Northmoor Road in the City of Highland Park be and the same is hereby changed to that of Melody Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Oak Grove Avenue in the City of Highland Park be and the same is hereby changed to that of Indian Tree Drive, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Oakdale Lane in the City of Highland Park be and the same is hereby changed to that of Turnstile Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Oak Lane in the City of Highland Park be and the same is hereby changed to that of Lilac Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Oak Ridge Avenue in the City of Highland Park be and the same is hereby changed to that of Hedge Run, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Park Lane Court in the City of Highland Park be and the same is hereby changed to that of Alta Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Pleasant Court in the City of Highland Park be and the same is hereby changed to that of Iris Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Westwood Street in the City of Highland Park be and the same is hereby changed to that of Meadowdale, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Woodcrest Lane in the City of Highland Park be and the same is hereby changed to that of Hemlock Lane, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Woodside Place in the City of Highland Park be and the same is hereby changed to that of Hedge Run, by which name it shall, after the effective date of this ordinance, be known and designated;

The name of the street known as Wood Corte in the City of Highland Park be and the same is hereby changed to that of Locust Court, by which name it shall, after the effective date of this ordinance, be known and designated;

The certain streets in the City of Highland Park known as Deere Park Drive S. Deere Park Drive S. E. and Deere Park Drive S. W., combined, are hereby changed collectively to that of South Deere Park Drive, by which name said combined streets shall, after the effective date of this ordinance, be known and designated;

The certain streets in the City of Highland Park known as Devonshire Court and Devonshire Road, combined, are hereby changed collectively to that of Devonshire Court, by which name said combined streets shall, after the effective date of this ordinance, be known and designated;

That portion of the street known as Lincoln Avenue lying southeasterly of Forest Avenue in the City of Highland Park be and the same is hereby changed to Lincoln Avenue South, by which name it shall, after the effective date of this ordinance, be known and designated;

That portion of the street known as Lincoln Avenue lying westerly of Forest Avenue in the City of Highland Park be and the same is hereby changed to

The certain streets in the City of Highland Park known as Main Street and West Street, combined, are hereby changed collectively to that of Highmoor Road, by which name said combined streets shall, after the effective date of this ordinance, be known and designated.

SECTION II. The change in street names herein provided shall be effective upon date of January 1, 1951.

SECTION III. This ordinance shall be in full force and effect from and after its passage, approval, recordation and upon the effective date above specified.
