PUBLIC NOTICE IS ALSO hereby given that Guy O. Lunn, County Treasurer and ex-Officio County Collector of Lake County in the State aforesaid will on September 25, A.D. 1950, before the County Court of Lake County, Illinois, in the Court House in the County House in the City of Waukegan in said County and State, make application for judgment against the said lands, town lots and real property hereinafter described for the amount of said special assessment, matured installments thereof, interest and costs due thereon and for an order to sell said lands, town lots and real property for the satisfaction thereof. Take notice further that the said Guy O. Lunn, County Treasurer and ex-Officio County Collector for the County of Lake and State of Illinois, will, on the 25th day of Monday succeeding the date on which judgment shall be taken to-wit: the 9th day of October, A.D. 1950, offer and expose to public sale at the Court House in the City of Waukegan, Lake County, Illinois, all or such portions of the property hereinafter described for the amount of special assessment and matured installments of special assessments, interest and costs due thereon for which judgment shall have been taken and shall remain unsatisfied. Said sale will commence at the hour of nine o'clock A.M., Central Standard Time on the 9th day of October and will continue from day to day until the same shall be completed. If for any cause such judgment shall not be rendered on said 25th day of September, then such sale shall commence on the 2nd Monday after such judgment shall be rendered.

Payment of delinquent special assessments may be made to the City Collector any time prior to date of tax sale.
