Mason Smith Reports On ECA Agency In Europe

"There are certain residual assets in the Economic Cooperation Administration which should be retained for our national advantage," Mason Smith told the congregation of The Highland Park Presbyterian Church at its annual meeting Wednesday evening, April 4. He has only recently returned from Europe where he appraised the E.C.A. in his capacity as a partner of A. T. Kearney & Co., management consultants.

"I left for Europe frankly skeptical of the agency but I returned enthusiastic about many features of the program," he confessed.

"The key men are top quality executives and administrators who were drawn together in an amazingly efficient operation, largely through the genius of Paul Hoffman. Of course mistakes were made, but they were few—very few, considering the rapidity with which so tremendous an organization was set up."

"These men, drawn from high salary positions in top management levels are there to render patriotic service and they have done a very good job. There are some lawyers, accountants and similar personnel who have spilled over from the New Deal, but their influence is substantially balanced by these seasoned business executives," he said.

"I actually saw the E.C.A. budget and it was worked down to no people and no money in 1952. With the establishment of the North Atlantic Treaty Organization, however, it is imperative—if the Americans' tax money is to be used profitably—that wasteful methods of procurement and endless red tape in dealing with diverse countries be eliminated as far as possible. No one can generalize on these complex matters, but I am convinced that the E.C.A. personnel knows best what countries and what agencies can best produce specific products. And E.C.A. personnel knows how to cut through the red tape and get the work done quickly and efficiently."

Dr. Irene Josselyn Medical Head Of North Shore Clinic

The North Shore Mental Health Association, which is sponsoring the founding of a mental health clinic to serve the five North Shore villages, announces the appointment of Dr. Irene Josselyn of Highland Park as medical director of the clinic. This clinic, to be located in the Highland Park Hospital, will be available to residents of Wilmette, Kenilworth, Winnetka, Glencoe and Highland Park. It will be administered by the Association, of which Mr. William H. Trout of Winnetka is president, in cooperation with the Hospital Board.

Mrs. Louis P. Haller of Highland Park, chairman of the Personnel committee, which has selected Dr. Josselyn as director says: "Dr. Josselyn's outstanding professional qualifications, her extensive experience in work with social agencies and community organizations serving all age groups, her warmth of personality and completely unselfish sense of public service, make her an ideal medical director for this inter-community clinic." Miss Marion McBee, head of the Field Service for the National Association of Mental Health describes Dr. Josselyn as "one of the best qualified psychiatrists in this country for this type of clinic work."

Other members of the Personnel committee of the North Shore Mental Health Association are: Mrs. Alvah Newcomb of Wilmette, Mr. Paul Hill and Mrs. C. H. Ross of Winnetka, and Mrs. David Levinson of Highland Park.
