Mr. GALBRAITH moved that the Bill to extend the powers of the Gore District Mu. tual Fire Insurance Company, be read a second time on Wednesday next. Carried.

FIRST READINGS.

Hon. Mr. WOOD introduced a Bill to an. thorise the trustees of Mrs. Carrie Robert Wilkes to convey to her certain real and personal property.

Hon, Mr. McMurrich introduced a Bill to authorise George Taylor and D. Cook to convoy certain trust lands.

Mr. CUMBERLAND introduced a Bill to incorporate the Rama Timber Transport Company.

Mr. COYNE latroduced a Bill, entitled an Act respecting Real Estate in Ontario The mover explained that the object of the meaenre was to facilitate proceedings and lessen the expense of parties applying to Court in matters respecting real estate. By the proposed amendment, a party had full power to apply to the judge in chambers, just as he has now in full court.

The Bill was ordered for a second reading

on Friday next.

Mr. OLARKE introduced a Bill to authorise and empower the Corporation of the City of Kingston to sell and convey certain of their lands,

Mr. EYRE introduced a Bill to amend the Act 27 and 28 Vic. c. 28, entitled an Act respecting the offices of sheriffs, and to make further provision regarding said offices, Ordered for a second reading on Wednesday next.

## ONTABIO COLLEGE.

The house went into committee on Sir Henry Smith's Bill respecting Ontario College -Mr. Hooper in the chair,

Sir HENRY SMITH explained that a similar Bill had been carried through Parlia. ment before, regarding a college in the diocess of Huron. For the present college, the land had been already purchased, a fine building had been erected on it, the college was in full operation, and masters were permanently engaged in the discharge of their duty. The County of Prince Edward had been selected as being a healthy and central place, and the counties surrounding the Bay of Quinte, and also the cites, sent their young men there for educational purposes. He moved the adoption of the let clause.

Hon, Mr. CAMERON-The College will not require Government aid? (Hear, hear).

Sir HENRY SWITH said there was nothing of the kind asked for in the Bill; and he had that confidence in the hon. the Premier that when the time came for such grants, this college would not be treated differently from other institutions.

Mr. FERGUSON objected to this measure as a plece of special legislation. He saw no necessity for this Act of iccorporation at present, and thought it might be deferred till Government brought down a general measure, under which it could come. It would be wise to stop this species of legislation at the outset. For his part, he would like to see these places incorporated, but it ought to be done by a general Act. Besides, this Bill asked for some \$13 000 of a yearly annuity, and that was a large sum for any body to control. Still, if all parties were served alike, it would not be so bad. He would repeat that this was one of the most dangerous pieces of legislation they could deal with, and one that would infallibly end in discord and confusion. All parties would be coming forward, and none would be satisfied. He hoped, then, that the hou, and gallant mover would not press the measure.

Mr. SCOTT-Perhaps the hon gentleman himself would prepare a general Bill.

Mr. FERGUSON understood the member for Ottawa very well. He would allow this measure to slip through, and then come down and ask for a grant for some other institution of similar powers. He (Mr. Ferguson) would like to see all these institutions on a parallel, and hoped a general measure
