As a priof that the principle of hollow walls is a correct one, I may mention that the Parliament Buildings, at Ottawa, are built with hollow walls, being faced with coursed stone on the cutside, but, of course, of a much more expensive character. The third charge is that "the lumber is of the commonest kind, full of large and loose knots, many of which have fallen out." In reply I have to state that the lumber used in the frames is of the usual quality, and the workmanship is also of a good character, the writer may have seen some lumber intended

to be used for deafening boards, which are now on the ground, and which are quite good enough for that purpose. If the writer of these charges had made enquiries of the clerk or foreman of the works, the latter a builder of much experience, it might have resulted differently, but the object would not have been attained, namely, fault finding alone, which can answer no good purpose.
