COMMITTEE OF WAYS AND MEANS.

On motion of Mr. Mackenzie it was agreed to receive the report of the Committee on Ways and Means on Tuesday next.

THE AGRICULTURAL AND ARTS ACT.

Mr. RYKERT, in moving the second reading of the Bill to amend the Act of the Province of Ontario, entitled "An Act to amend the Agricultural and Arts Act;" briefly explained the objects of the Bill. It had been the rule, he said, for four members to retire from the managing Board of the Agricultural Society each year; last year that custom was superseded, but he hoped it would be renewed, as he believed it was in accordance with the wishes of the people.

Hon. Mr. CARLING thought it better for the members of the Doard to be elected year; they could then be called to account if they failed to do their duty.

Hon. Mr. McKELLAR thought it important that some at least of the old members should go back each year, as they understood better the working of the Society than new members were likely to do.

Hon. Mr. CARLING maintained that it would be better for each member to be elected every year, as they were holding large amounts of money in their hands, and they were equally responsible in that respect with the municipal candidates who were elected annually.

Hon. Mr. BLAKE thought it would be advisable to give a fair trial to an Act of this kind, to see how it would work, before amending it.

The Bill was then read a second time and referred to a select committee.

THE GAME LAWS.

Mr. PRINCE moved the second reading of a Bill to consolidate and amend the laws for the protection of game and furbearing animals in Ontario, and made a few remarks in explanation of the Bill. There were several descriptions of game for the protection of which legislation was much required. The subject had attracted much attention lately, and he had received letters from all parts of the Province on the subject since introducing this Bill. Of course the chief point to sportsmen was what time should be made the legal period for killing game. The difficulty heretofore had been that the period during which game was fit to kill; varied considerably in the eastern and western sections of the Province.

Mr. SCOTT (Grey) trusted the Bill to be brought before the Committee would be of a nature to settle the question of the game laws for some time.

Mr. H. S. MACDONALD thought the hon, member for Essex deserved a great deal of praise for introducing that Bill, and hoped some special clause would be introduced with regard to the protection of of legislation.

deer.

Mr. DEACON said that in Renfrew and that neighborhood, hunting parties from the States were in the habit of killing large quantities of deer and sending them off for sale. The preservation of deer was of the highest importance to the people of that district, who were to a very great extent dependent upon that for their meat supp'y; but they were at present in a great measure deprived of it by in-
