vation to which he wanted to call the attention of the hon, member for East Toronto, that in New York, where were some of the ablest jurists in the world, the judges were elected every eight years, and nominated by a political party. During his intercourse with lawyers in the State of New York, he never heard of one complaint that a judge so elected by a party had ever been swayed or influenced in his judgments however strong the feeling might have been between the parties. A judge never thought of the political principles of the litigant before him. His only desire was for a strict administration of justice. (Hear, hear.)

The clause was thne carried.

Attorney-General MOWAT moved that a

selecticommittee, composed of himself, Hon. Mr. Crooks, Mr. Caldwell and Mr. Wells, be appointed to draft an address to His Excellency. Carried.

Attorney-General MOWAT prosented the report of this committee, which was adopted; and the address was ordered to be presented by such members of the committee as were members of the Executive Council.

The House then adjourned at 12:10 a m.
