Orangemen for all they had granted them. When the Commissioner of Crown Lands brought in his Bill for separate schools, who gave him assistance but the Orangemen and Conservatives of the country? With reference to the position of the Government in the matter, he said that it came with good grace from the hon. Treasurer to repudiate the Orangemen, after having hired a man to go into the Orange Lodges and traffic upon the bones of the murdered Scott. Ho disclaimed any intention of throwing a firebrand into the House, and asserted that no objection had been raised by Orangemen to. the many Bills passed in favour of Catholic institutions. There was no intolerance in the body; and he defied any Orangeman to say that in any Orange Lodge there was any inveighing against Catholics. He had heard more said against Catholics and Catholicism from a Presbyterian pulpit than he had ever heard in an Orange Lodge.

Mr. ROBINSON said that it had been charged that the Bill had been introduced with a view to promote dissention in the House, but he denied that. He was no Tory himself, and felt now that when a Conservative was taken into the Cabinet he had better have been left out. The member for Grenville had taken the most curious course that he could think of in his remarks about the Bill. That gentleman had certainly not evinced a liberal spirit, and his chocsing a Protestant wife was, perhaps, the most liberal thing he had ever done. He (the speaker) thought that the Attorney-General had clearly shown that the Orange Association was not a political one. He referred to the Fenian raids, and said that Orangemen had taken a foremost part in scattering the Fenian hordes that had invaded the country. The Bill was a just one in every particular, and if the member for South Leeds had abandoned it he himself would have brought it up again.

A division was then taken on the amendment of the member for South Leeds, which was carried. Yeas, 38: nays, 30.

Mr. Boultbee had paired with Mr. Monk, at present in Ottawa, who is in favour of the Bill; but as Mr. Boultbee advocated sending the Bill back to Committee, he recorded his vote for Mr. Macdonald's amendment.

In the foregoing division Dr. Haney paired for with Mr. Wells against the amendment.

Mr. Watterworth paired for with Dr. Wilson against the amendment.

The motion as amended was then carried.
