The House again went into Committee on the Estimates, Mr. Wood (Victoria), in the chair.

On the item of \$1,000 salary for a shorthand writer in the Crown Lands Department, Mr. Rykert wished some explanation.

Hon Mr. SCOTT stated that far more business had been done in that department during the past year than in any other, either before or after Confederation, and he found it absolutely necessary that the services of a short hand writer should be obtained. The speaker quoted figures to show that the revenue of the department had vastly increased under his administration of its affairs, and he had disposed of many cases that had been before previous Commissioners for twenty years. This great increase in the business, he'thought was a sufficient justificstion for his employing whatever officials might be necessary for the efficient working of the departmental affairs He might also mention that in 1868 the letters received at the Department numbered 11,000; in 1869 and 1870, 15,000 odd; in 1871, 17,380; while in 1872 the number increased to 21,614; and during the two and a half months of the present year they had increased at the rate of
