Bill to confer on municipal corporations a4. ditional power in respect to fences bordering on public highways, explaining that the object of the Bill was to confer on municipal corporations additional powers in reference to fences bordering on highways which were liable to obstruction by snow-drifts. The Bill gave power to municipal corporations to require a certain class of fence, or to employ statute labour to remove pertions of the fence during the winter and to replace them in the summer. He intended to mave to make the Bill compulsory instead of permissive, in order to prevent roads which ran through two townships being clear for a part of the way, wille farmers might be blocked half. way to market.

Mr. ROSEVEAR said the Township Councils were the proper parties to deal with this question,

Mr. SINCLAIR said he didn't think it would be any harm to allow the Bill to go to Committee, for certainly the matter referred to was a very great grievance in the western part of the Province.

Mr. PARDEE said he agreed with the hon, member for North Bruce that it would perhaps be well to allow the Bll to go to a Special Committee, as thereby some scheme might be devised for erecting fences which would prevent the drifts which were such a grievance in some parts of the Province.

Mr. LAUDER concurred in the view that a permissive Act should be passed on the subject, for he was aware how serlous the evil complained of was in some parts of the country.

Mr. GIBSON hoped the Bill would go to the Committee, for if it was merely permissive, no great harm could be done.

Mr. BETHUNE said that in some of the United States wire fences had been found very serviceable, while in Lower Canada regulations were in force obliging property. holders to take their fences down during the winter.

Mr. CAMERON said the expense should not be borne by private individuals, but by the public.

Mr. GRANT thought the Bill should not be made compulsory.

Mr. BISHOP said he hoped the Bill would go to Committee, though he considered the plan suggested in the Bill would make matbelieved it should be left in the hands of the Council to order fences to be taken wholly or partially down during the drifting season.

Mr. GRAHAM (Lambton) said it would be impracticable in many parts of the country to have the fences pulled down during snow. storms, for they would have to be re-created during thaws. He thought the Township Connoils should be empowered to pass by. Is we to have the side lines opened,

After further discussion the motion was carried, the Bill read the second time, and re'erred to a Special Committee.

RETURNS

Mr FRASER presented a return of cor. respondence relating to the Toronto Eye and Her Infirmary. Also, a return of applications made for admission to the Lunatic Asylums in 1874 and 1875.

Mr. MERRICK said he would like to ask when the returns asked for in reference to the School of Technology would be brought down?

Mr. CROOK I said they were not usually brought down until the end of the year, but he had given orders to have them as soon as possible.

Mr. MACDOUGALL (Simcoe) asked when the case of the Dominion Government, in the boundary question, would be brought down?

Mr. MOWAT said he had telegraphed to Ottawa to have copies sent down.

SUPPLY. Mr. CROOKS moved the House into Committee of Supply.

Mr. CAMERON objected to going on with further items of proposed expenditure until the report of the Inspector of asylums and prisons was before the House, Mr. MOWAT moved the adjournment of

the House. The House adjourned at 5:30,
