#### REPORTS AND RETURNS.

Mr. HARDY presented the report of the School of Practical Science, and the prospectus of the course of instruction therein; the report of the Depository Branch of the Educational Department; the statement of the Bursar of the University of Toronto and Upper Canada College of the cash transactions for the year ending the 30th June, 1878; the report of the distribution of the Revised Statutes of Ontario and the Sessional Statutes; and the eleventh annual Report of Asylums, Prisons, and Public Charities.

#### THE SCHOOL LAW.

Mr. CROOKS introduced a Bill respecting Public, Separate, and High Schools. He said it contained three prominent features, viz., it extended the franchise, provided for a less expensive mode of holding school elections, and made provision for placing checks on the expenditure on capital account both for Public and for High Schools. These checks would be in the vote of the rate. payers in certain cases, and in others the councils of cities and towns would have a certain discretion in complying or not with the demands made upon them from time to time by School Boards. The Bill also contemplated remedying some defects which experience had shown to exist in the law as it now stood. He would make fuller explanations on the second reading of the Bill.

Mr. MEREDITH-Is it proposed to extend the ballot?

Mr. CROOKS replied in the negative.

The Bill was read a first time.

EAST KENT LICENSE INSPECTOR,

Mr. HARDY—In answer to the question asked yesterday by my hon, friend the member for London in regard to the License Inspector for East Kent, I may say that no appointments have been made this year to the position spoken of, and that none will be made so long as the individual indicated continues in the position of Reeve.

### CARDWELL LIQUOR LICENSES.

Mr. FLESHER moved for an order of the House for a statement showing in detail the total amount received by the License Commissioner of Cardwell for tavern and shop licenses and fines for infringement of the license laws during 1878. Also, to show in detail all payments out of the License Fund of Cardwell since the 1st of May, 1878, the person or persons to whom, and the authority on which, such payments were made, and the amount of the balance on hand on the 1st day of January last.—Carried.

RECEIPTS AND EXPENDITURES FOR 1878.
