enced in following the items under the present system; as the matter would be remedied by the printing of a larger number of the resolutions, and their distribution to the members, he did not see why that could not be done.

The following items were also concurred in:-Works in Nipissing District, \$200. Works in Muskoka District, \$550. Works in Parry Sound District, \$550. Works at Muskoka River, \$8,000. Works at Gull and Burnt Rivers, \$8,780. Surveys, inspections, &c., \$5,000. Locks, dams, &c., \$6,000. Lockmasters' salaries, &c., \$2,000.

On the item Refunds, \$59,680 23.

Mr. ROSS said that six per cent. of the amount of the Land Improvement Fund was deducted before it was paid over to counties, although the Order in Council provided that one-fourth of the amount should be paid over without any deduction whatever. The land was to be sold at ten shillings an acre, and the counties were to be paid at the rate of two shillings and sixpence per acre.

Mr. WOOD said that no alteration could be made now, as any change in the direction proposed by the hon, gentleman would be increasing the estimates.

Mr. ROSS said that the statute provided that two shillings and sixpence per acre should be set apart as a Land Improvement Fund to be paid over to the counties. The six per cent. was not to be deducted from that fund, but from the whole Common School Bund, before any distribution was made between Ontario and Quebec. It was a distinct bargain between the settlers and the Crown that one-fourth of the amount received from the sale of the lands should be paid over to them for the purpose of constructing roads, harbours, &c., and he maintained that the Legislature had no right to step in and set that bargain aside. He hoped the Government would take the matter up and pay the counties the full amount without any deduction at all. Interest was accruing upon the Fund, and the settlers were entitled to that as well as to the principal.

Mr. SCOTT was inclined to agree with the construction placed upon the statute by the hon. member for West Huron. He did not see that any objection could be taken to placing the increased amount in the estimates, as it was a statutory enactment. The item was passed.

The House adjourned at 10:45.
