tention of the Government to continue the ser-

vices of the License Commissioner and In-

spector for the current year in the County of Lambton, owing to the Scott Act taking effect in that county on the first day of May next, and if so, from what source will their expenses be paid? Mr. HARDY said that the Government had the matter under consideration, and would probably introduce certain legislation respecting it. Until they did so they could not announce their policy on the subject.

LAND IMPROVEMENT FUND.

Mr. HAY moved an address to the Lieuten-

ant-Governor, praying that he will cause to be laid before this House a return of any correspondence or papers which may have passed between the Government of Ontario and the Government of the Dominion in respect to the Land Improvement Fund. He explained the origin of the fund, saying that it arose from thesale of certain School Lands and Crown Lands, the proceeds to be applied to the promotion of local improvements in the municipalities in which the lands were located. The Treasurer had been applied to by members representing the localities where these lands were situated. The people were anxious to know why they did not have it at once, and were blaming the Government for the delay. They had censured the Government for not taking energetic steps in the matter. He presumed there was correspondence on the subject, and that it would show the House just where the responsibility
