people insisted, give up your contention. (Cheers and laughter.) But Omtario should have her rights, even if she had to wrest them from those who held them from her. (Cheers and counter-cheers.) He combatted the statement of the member for London (Mr. Meredith) that the situation was not changed by any legislation during the last session at Ottawa. By giving Manitoba jurisdiction they had introduced a third power without whose assent Ontario could never obtain possession of the disputed territory.

Mr. MEREDITH-Does the hon. gentleman mean to say that by the legislation of last session

the situation was changed at all?

Mr. HARDY said it certainly had been, for the territory had been given over to Manitoba, thus

introducing her as a party in the dispute.

Mr. MEREDITH said Manitoba's eastern boundary, was extended to Ontario's western boundary, wherever that might be, and there was no interference with the bounds of Ontario.

Mr. HARDY said since that time the Dominion Government had issued a map on which the territory in dispute was shown as belonging to Manitoba, and thus this great Province of Ontario, the most populous, the most wealthy, the most advanced intellectually, was despoiled of her territory and made to appear only one-half the size of Quebec, and two-thirds the size of Manitoba, as at present represented. It would be seen by reference to a recent lecture given by Sir Francis Hincks, that the decision arrived at by the Boundary Arbitrators was unanimous, and was arrived at singly by each of them without consent. He concluded by predicting that if the Opposition goes to the country at the next election on the question of unlimited veto and half of the territory justly due to Ontario, they would not be returned with a corporal's guard. (Cheers.)

Mr. WHITE moved the adjourument of the

debate.

The House adjourned at 10:35.
