marked that he did not remember having given it as his opinion that the omission to open and hold polls had voided the election.

MOTIONS.

Mr. MEREDITH moved the motions standing in his name for returns regarding the appointment of G. R. Pattullo and George Burden, and the correspondence with them; for a statement of claims brought before them as Commissioners; for a return of the expenses in connection with the disputed territory; for a statement of the timber cut in the disputed territory. The motions were carried.

ALGOMA VOTE.

Mr. MEREDITH also moved for copies of the writ for holding the Algoma election and papers regarding the fixing of polling places. He made complaint that polling places had not been fixed at certain places.

Mr. MOWAT in reply showed that the statute

strictly defined the manner in which the polling places should be fixed; and if anything had been done otherwise than as directed by law, the vote cast at the election would have been lost, and then a claim would have been made that persons had been entrapped into voting at places where he knew they would be lost. There were twenty places mentioned in the Act as places where polls should be opened; an Order in Council was passed fixing twenty more, and the returning-officer having called attention to the need of more his recommendations were met by an Order in Council. The member for London had called attention to the fact that the returning-officer had not opened a poll at Cockburn Island. Surely ne knew that if the returning-officer had done so the vote had been lost, and then the 50 or 60 votes which were cast for Mr. Plummer would have been lost, as they would have voted there instead of going eisewhere, which they did. There had been polls at every place at which one had ever been held and many more.

burn Island had gone to vote at Thessalon, and about 80 votes were there received as coming from Cockburn. The fact was that many Detroit fishermen came over and voted who would not have been able to vote at Cockburn Island, as the deputy returning-officer would have known them and prevented them from voting. As a matter of fact a member of Parliament had worked up public feeling and got every man to sign a paper promising to vote against Mr. Lyon-not because of the policy of the Government or its administration, but for the reason stated.
