## LEGISLATIVE COMMITTEES.

Mr. J. M. Gibson, of Hamilton, presided at the Committee on Private Bills yesterday. Mr. Gray's bill to empower the municipality of the village of Parkdale to make special assessments was first taken up. Mr. Sheplev appeared for the Parkdale Council. Mr. Kerr, Q.C., and Dr. Snelling represented property-owners and parties injuriously affected by the Queen-street subway. Mr. Shepley said it was not proposed that the bill should cover any by-law passed or repassed regarding the subways. Mr. Black, representing other ratepayers, and the other opponents to the bill, withdrew his objections. The bill was reported with slight amendments. Mr. Harcourt's bill respecting the will of the late Samuel B. Smith, was reported with slight amendments.
