must be either from the organs of the party or from the utterances of its representatives. Nobody would deny that The Mail had raised the No Popery cry. The Mail was the organ of the Tory party, specially recognised by a convention of that party, and it continued so until it was seen that the No Popery cry was doing the party more harm than good. The No Popery cry was raised most assiduously during the whole campaign in Haldimand. The leader of the Opposition at length repudiated the cry, but repudiated it very gently. His election address on this point was so ambiguous that The Mail, which raised the No Popery cry, declared that it was quite satisfied with Mr. Mcredith's declaration. (Checrs and laughter.)

Mr. MEREDITH-What is the No Popery

cry?

Hon. O. MOWAT said that if his hon. friend was so innocent as not to know what the No Popery cry was, he utterly despaired of I giving him any light upon it. (Laughter.) His f members of the Legislative Assembly. hon, friend had referred to

and he found himself unable to defend the position of his friends at Ottawa on that subject. His hou, friend, however, claimed great credit because our rights there were no longer disputed. Why, they had no power to dispute it; the Privy Council had settled that question. The Dominion Government were to blame because they still refused to obtain Imperial legislation, ratifying the judgment of the Privy Council. They were to blame, too, because they refused to relinquish their claim to the timber lands and

minerals of the disputed territory, although the Courts had decided against them, and although nearly every other Province in the Dominion owned lands in the same position, and were allowed to deal with the minerals, lands and timber as they pleased. Then his hon. friend had referred to

### THE FACTORY ACT.

The Dominion Government had for a long time claimed the right to pass a Factory Act, and it was for this reason that he advised that the putting into force of the Act should be postponed until the issue of a proclamation. He desired to have the matter settled in a friendly way. Mr. Thompson, the Dominion Minister of Justice, had asked him (Mr. Mowat) what reasons he had for doubting the validity of the Act. His reply was, "It is not I, but your own colleagues, who have taken that ground." He had proposed to Mr. Thompson that the Dominion Government should say publicly that they did not dispute the validity of the Act. That was refused. He had proposed that the matter should be settled in the courts in a friendly way, and that was refused. There were several other matters to which the leader of the Opposition had referred, which he would deal with at a later period of the session. The fact was that the No Popery cry was the only point on which the Government had been attacked during the elections. On nine-tenths of the platforms that was the cry they had to meet. The electors had said that the Government was right, and that his hon. friend opposite was wrong, and he believed the present session would tend still more clearly to show that the people had decided rightly. (Cheers.)
