the qualification for councillors in rural municipalities. Read a second time and referred to

Municipal Committee.

Mr. GUTHRIE moved the second reading of it the bill to amend the Municipal Act. The bill reduces the qualification for councillors, and provides that where a municipality is cast in damages for an accident occasioned by the defective state of a road and the detective state is caused by the action of a third party, the municipality shall have a remedy over against that third party. The bill also contains some new provisions regarding the control of bridges. Bill read a second time and referred to the n Municipal Committee.

Mr. BIGGAR'S bill to amend the Assessment Act was read a second time and referred

to the Municipal Committee.

Mr. MEREDITH said the object was to escape the operation of the Scott Act, which

was in force in Kent and not in Essex.

Hon. C. F. FRASER said that this was only an incident of the proposed change. people of the village had a right to be heard on the question of whether they preferred to live under the Scott Act or not.

The bill was referred back to the Committee

on Private Bills.

STATE OF PUBLIC BUSINESS.

Mr. MEREDITH suggested that business might be expedited by not holding any session of the House on Friday next, but devoting the whole day to committee work.

Hon. O. MOWAT accepted the suggestion. Mr. MEREDITH said he hoped the mem-

bers of the House would not go home.

(Laughter.)

Hou. Mr. HARDY brought down the report on immigration, a return relating to schools in Prescott and Russell, and the papers connected with the new Parliament buildings.

Hon. Mr. FRASER moved that the last return be printed. Carried.

The House adjourned at six until Monday.

COMMITTEES.

PRIVATE BILLS.

The Private Bills Committee met, Mr. Gibson (Hamilton) in the chair. The bill relating to the Western Fair Association was passed, the clause giving the association power to expropriate lands being restored. The bill contirming the annexation of New Edinburgh to Ottawa was reported, after two amendments had been made. One of these had reference to a bridge joining Edinburgh and Ottawa, and i gave the arbitrators power to consider the claim of the County of Carleton to be recouped the second reading of the bill to incorporate a portion of its share of the cost. The bill contained a provision authorising the City of Ottawa to make an arrangement with the Dominion Government whereby the latter should control the city police. This legislation was . asked for at the suggestion of the Dominion Government. A large majority of the committee were indisposed to surrender this jurisdiction to the Dominion, and the provision was struck out of the bill. The following bills were reported :- Respecting the town of Sault Ste. Marie; authorising M. B. Mallory to practise as a dentist; authorising Adelia Gc uld as trustee to execute a certain conveyance, and authorising the trustees of Warwick church to sell certain lands; respecting the Fort George Assembly, to be hereafter known as the Niagara Assembly; amending various Acts relating to the Long Point Company.

MUNICIPAL LAW.

The Municipal Committee met this morning, Mr. Har ly presiding in the absence of the Treasurer. It was agreed that the bills increasing; the exemptions on salaries be the; first order for the day (Friday); that Thursday next be appointed to consider the bills re-Hon. O. MOWAT said he could answer lating to ditches and watercourses, and to hear for his friends attending to their duties. 'the representations of ditches and water-· courses engineers and municipal engineers in regard thereto, and that on Tuesday next the bill relating to bridges be taken up.
